13 The Texas Workforce Commission (Commission) proposes amendments to the following

41 **PART I. PURPOSE, BACKGROUND, AND AUTHORITY**

42 The purpose of the proposed Chapter 809 rule change is to make amendments to the
43 Commission's Child Care Services rules to address changes resulting from the Child Care and
44 Development Block Grant Act (CCDBG Act) of 2014. The proposed amendments to Chapter
45 809 also include, where appropriate, changes in rule language based on the Notification of
46 Proposed Rulemaking (NPRM) issued December 24, 2015, by the U.S. Health and Human
47 Services Administration for Children and Families.
48

1 The CCDBG Act authorizes the federal Child Care and Development Fund (CCDF), which is the
2 primary federal funding source for providing child care subsidy assistance to low-income
3 families and for improving the quality of care for all children. The Texas Workforce
4 Commission (Agency) is the CCDF Lead Agency in Texas. The CCDF program is administered
5 by the 28 Local Workforce Development Boards (Boards). Additionally, the Texas Department
6 of Family and Protective Services (DFPS) is responsible for administering the health and safety
7 requirements of the CCDF program.

8
9 On November 19, 2014, President Obama signed the CCDBG Act of 2014, reauthorizing the
10 CCDBG Act for the first time since 1996. The new law makes significant changes to the CCDF
11 program, designed to promote children's healthy development and safety, improve the quality of
12 child care, and provide support for parents who are working or in training or education.

13
14 The primary purpose of the Commission's proposed amendments to Chapter 809 is to implement
15 the following changes to the CCDF program resulting from the CCDBG Act of 2014:

16
17 *Twelve-Month Eligibility Period*

18 The CCDBG Act of 2014 added a 12-month eligibility and redetermination period requirement
19 for children determined eligible for subsidized child care. This change to the CCDF program is
20 designed to provide more stable assistance to families, protection for working families, and
21 increased opportunities for children to remain in child care services.

22
23 CCDBG Act §658E(c)(2)(N)(i) and (ii) require states to demonstrate in the CCDF State Plan that
24 after initial eligibility each child who receives assistance will be considered to meet all eligibility
25 requirements for such assistance and will receive such assistance for not fewer than 12 months
26 before the state or designated local entity redetermines the eligibility of the child, regardless of
27 changes in income--as long as income does not exceed the federal threshold of 85 percent of the
28 state median income (SMI)--or temporary changes in participation in work, training, or
29 educational activities.

30
31 Therefore, a state shall not terminate assistance prior to the end of the 12-month period if the
32 family experiences a temporary job loss or temporary change in participation in a training or
33 educational activity.

34
35 Although the CCDBG Act requires a period of 12-month minimum eligibility and receipt of
36 child care services prior to redetermination, §658E(c)(2)(N)(iii) allows states the option to
37 terminate eligibility due to a permanent (nontemporary) change in work, training, or education.
38 However, the CCDBG Act requires that prior to terminating a subsidy, the state must continue to
39 provide child care assistance for a period of at least three months to allow parents to engage in
40 job search, resume work, or attend an educational or training program as soon as possible.

41
42 *Parent Share of Cost during the 12-Month Eligibility Period*

43 To support continued care throughout the 12-month eligibility period, NPRM §98.21(a)(3):
44 --prohibits states from increasing the parent share of cost during the 12-month eligibility period,
45 regardless of increases in the family income; and
46 --requires that states act upon information provided by the parent that would result in a reduction
47 in the parent share of cost.

1 NPRM §98.21(b)(2) allows increases in the parent share of cost for instances in which the family
2 has exceeded a state's initial eligibility income threshold, but still remains under the federal 85
3 percent of SMI.

4
5 Finally, NPRM §98.45(k)(2) requires that the parent share of cost be based on income and the
6 size of the family and may be based on other factors as appropriate, but may not be based on the
7 cost of care or amount of the subsidy payment.

8
9 *Graduated Phaseout of Eligibility*

10 CCDBG Act §658E(c)(2)(N)(iv) requires Lead Agencies to have a "Graduated Phaseout of
11 Eligibility" that includes policies and procedures to continue child care assistance at the time of
12 redetermination for children of parents who are working or attending a job training or
13 educational program and whose income has risen above the Lead Agency's initial income
14 eligibility threshold to qualify for assistance but remains at or below 85 percent of SMI.

15
16 *Income Calculation to Consider Irregular Income Fluctuations*

17 CCDBG Act §658E(c)(2)(N)(i)(II) requires that states take into consideration irregular
18 fluctuations of earnings when calculating income for eligibility. NPRM §98.21(c) further
19 clarifies this requirement by adding that the calculation of income policies ensures that
20 temporary increases in income, "including temporary increases that result in monthly income
21 exceeding 85 percent of SMI (calculated on a monthly basis), do not affect eligibility or family
22 co-payments."

23
24 *Priority and Eligibility for Children Experiencing Homelessness*

25 CCDBG Act §650E(3)(B)(i) and NPRM §98.46(a)(3) and §98.51 require states to give priority
26 for services to children experiencing homelessness. NPRM §98.2 defines a "child experiencing
27 homelessness" as a child meeting the definition of homelessness under the McKinney-Vento
28 Homelessness Act of 1987 (McKinney-Vento Act).

29
30 The NPRM preamble clarifies that Lead Agencies have flexibility in how they offer priority to
31 these populations, including by prioritizing enrollment, waiving copayments, paying higher
32 rates for access to higher-quality care, or using grants or contracts to reserve slots for priority
33 populations.

34
35 Additionally, the CCDBG Act and the NPRM require that state procedures permit enrollment
36 (after an initial eligibility determination) of children experiencing homelessness while required
37 documentation is obtained.

38
39 *Attendance and Provider Reimbursements*

40 CCDBG Act §658E(c)(2)(S) and NPRM §98.45(m) require implementation of provider payment
41 practices that:

- 42 --align with generally accepted payment practices for children who do not receive CCDF funds;
43 and
44 --support the fixed costs of providing child care services by delinking provider payments from a
45 child's occasional absences.

46
47 *Consumer Education Information*

1 CCDBG Act §658E(c)(2)(E) and NPRM §98.33 require that states collect and disseminate,
2 through a consumer-friendly and easily accessible website, consumer education information to
3 parents of eligible children, the general public, and, where applicable, providers regarding:
4 --availability of the full diversity of child care services;
5 --quality of providers;
6 --state processes for licensing, conducting background checks, and monitoring child care
7 providers;
8 --other programs for which families that receive child care services may be eligible;
9 --research and best practices concerning children's development; and
10 --state policies regarding social-emotional behavioral health of children.

11
12 Additionally, NPRM §98.33(d) requires that parent consumer education information also
13 include:

14 --licensing compliance information for the provider selected by the parent;
15 --how to submit a complaint regarding a child care provider;
16 --how to contact community resources that assist parents in locating quality child care; and
17 --how CCDF subsidies are designed to promote equal access to the full range of child care
18 providers.

19
20 CCDBG Act §658E(c)(2)(E) also requires that Lead Agencies provide eligible parents with
21 information on existing resources and other services in the state that conduct developmental
22 screening and provide referrals and services, when appropriate, for children eligible for
23 subsidized child care, including:
24 --the Medicaid Early and Periodic Screening, Diagnosis, and Treatment program; and
25 --the Early Childhood Intervention (ECI) and Preschool Program for Children with Disabilities
26 developmental screening services.

27 28 **PART II. EXPLANATION OF INDIVIDUAL PROVISIONS**

29 (Note: Minor editorial changes are made that do not change the meaning of the rules and,
30 therefore, are not discussed in the Explanation of Individual Provisions.)

31 32 **SUBCHAPTER A. GENERAL PROVISIONS**

33 **The Commission proposes the following amendments to Subchapter A:**

34 35 **§809.2. Definitions**

36 *Attending a Job Training or Educational Program*

37 Consistent with CCDBG Act §658E(c)(2)(N)(i)-(ii), the definition of "attending a job training or
38 educational program" is amended to clarify that the requirement in the definition that the
39 individual be making progress toward successful completion of the program as determined by
40 the Board, is only applied at the parent's 12-month redetermination.

41
42 Consistent with the CCDBG Act, care cannot be discontinued during the 12-month eligibility
43 period for failure to make progress toward completion of an education or training program.
44 However, the NPRM allows additional eligibility requirements at the 12-month redetermination
45 period. Boards must ensure that the parent is making progress toward completion of the
46 program, as determined by the Board, when redetermining eligibility for continued care, but are
47 prohibited from making this a condition of eligibility at the parent's initial eligibility
48 determination. When developing policies and procedures for determining if the parent is making

1 progress toward completion of the program, the Commission cautions against relying solely on
2 the parent's grade point average (GPA), particularly one semester's GPA. If a Board uses the
3 GPA, the Commission encourages Boards to establish a minimum threshold that would
4 demonstrate if a parent has consistently failed to complete coursework during the eligibility
5 period.

6
7 The requirement in the definition that the individual must be considered by the program to be
8 officially enrolled in and meeting the attendance requirements of the program is retained without
9 change because enrollment and attendance in the program should be maintained throughout the
10 12-month eligibility period. Discontinuing care due to a nontemporary cessation of attendance in
11 a training or education activity during the 12-month eligibility period is addressed in §809.51(b).

12
13 As described in amended §809.73, parents are required to report items that impact a family's
14 eligibility during the 12-month eligibility period. Boards may develop procedures for
15 confirming continued enrollment and attendance during the 12-month eligibility period,
16 including requesting that education institutions and training providers confirm enrollment at each
17 semester and the resumption of training classes in order to determine that the parent has not had
18 a nontemporary cessation of education or training activities.

19
20 The Commission notes that the requirements in §809.41 requiring Board policies for child care
21 during education, including time limits or eligibility based on the type of education pursued by
22 the parent, are not changed by these amendments.

23
24 *A Child Experiencing Homelessness*

25 Consistent with NPRM §98.2, §809.2 is amended to add the definition for a "child experiencing
26 homelessness" as a child meeting the definition of homeless pursuant to the McKinney -Vento
27 Act.

28
29 *Child with Disabilities*

30 The definition of a "child with disabilities" is amended to align with the definition under §504 of
31 the Rehabilitation Act of 1973.

32
33 *Improper Payments*

34 The definition of "improper payments" is amended to align with the current definition of an
35 improper payment in CCDF regulation §98.100(d). The amended §809.2(11) defines an
36 improper payment as:

37
38 Any payment of CCDF grant funds that should not have been made or that was made
39 in an incorrect amount (including overpayments and underpayments) under statutory,
40 contractual, administrative, or other legally applicable requirements governing the
41 administration of CCDF grant funds and includes:

- 42 --to an ineligible recipient;
43 --for an ineligible service;
44 --for any duplicate payment; and
45 --for services not received.

46
47 *Regulated Child Care Provider*

1 The definition of a "regulated child care provider" is amended to remove providers licensed by
2 the Texas Department of State Health Services (DSHS) as a youth day camp as eligible providers
3 of subsidized child care services.

4
5 CCDBG Act §658H and NPRM §98.43 require that states have in effect "requirements, policies,
6 and procedures to require and conduct criminal background checks for child care staff members
7 of all licensed, regulated, or registered child care providers and all providers eligible to deliver
8 services." These requirements include a Federal Bureau of Investigation (FBI) fingerprint check.
9 Relative providers are exempt from this requirement, which must otherwise be implemented no
10 later than September 30, 2017.

11
12 DSHS youth day camps are currently exempt from DFPS child care licensing and monitoring
13 requirements. DSHS conducts background checks of staff in compliance with state law for
14 youth camps, but unlike the CCDBG Act and the NPRM, state law does not require an FBI
15 fingerprint criminal background check for youth day camp staff. Nonetheless, certain youth day
16 camps may be eligible for DFPS to license as child care centers. Therefore, to allow sufficient
17 time for day camps that serve subsidized children to choose to work with DFPS to become
18 licensed, the Commission will not implement this provision until September 30, 2017.

19
20 *Working*

21 The definition of "working" is amended to remove job search activities from the definition.
22 Child care during periods of cessation of work, job training, or education is addressed in
23 §809.51.

24
25 **SUBCHAPTER B. GENERAL MANAGEMENT**

26 **The Commission proposes the following amendments to Subchapter B:**

27
28 **§809.13. Board Policies for Child Care Services**

29 Section 809.13 is amended to remove the requirement in subsection (c) for Boards to submit
30 policy modifications, amendments, or new policies to the Commission within two weeks of
31 adopting the policy. This section retains the requirement that Boards submit Board policies to
32 the Commission upon request. The additional requirement to submit changes to policies within a
33 specific time frame is redundant. The Commission makes this change to reduce administrative
34 burden on both Board and Agency staff. Section §809.13 is amended to remove multiple Board
35 policy requirements that no longer apply under the CCDBG Act.

36
37 Consistent with the CCDBG Act 12-month eligibility period requirement, §809.13 is amended to
38 remove the requirement for Boards to have a policy on frequency of eligibility determinations, as
39 the frequency is now established under federal law.

40
41 Section 809.13 is amended to remove the option for Boards to have a policy to include provider
42 eligibility for nonrelative listed family homes. CCDBG Act §658E(c)(2)(K) requires annual
43 unannounced inspections of all CCDF-subsidized providers for compliance with health, safety,
44 and fire standards. Relative providers are exempt from this requirement. By state statute, listed
45 family homes are not inspected by DFPS child care licensing (unless there is a report of abuse or
46 neglect at the facility). Therefore, under the CCDBG Act, nonrelative listed family homes are
47 not eligible to provide CCDF-subsidized services.

1 Section 809.13 is amended to remove the requirement that Boards establish policies for
2 attendance standards in order to be consistent with CCDBG Act §658E(c)(2)(S), which requires
3 that provider reimbursement policies support the fixed costs of providing child care services by
4 delinking provider payments from a child's occasional absences. Attendance standards are
5 established in amended §809.78, and reimbursement policies based on enrollments are
6 established in §809.93.

7
8 Section 809.13 is amended to remove the requirement that Boards have procedures for imposing
9 sanctions when a parent fails to comply with the provisions of the parent responsibility
10 agreement (PRA). As explained in the changes to Subchapter D, the PRA is no longer a
11 requirement.

12
13 Section 809.13 is amended to remove the requirement that Boards have a policy regarding the
14 mandatory waiting period for reapplying or being placed on the waiting list. As explained in the
15 changes to Subchapter C, the mandatory waiting period is no longer required.

16
17 **§809.15. Promoting Consumer Education**

18 Section 809.15(b) is amended to clarify that consumer education information includes consumer
19 education information provided on the Board's website.

20
21 Section 809.15(b)(4) is amended to remove the requirement that Boards include in consumer
22 education information for parents a description of the school readiness certification system, as
23 the program has been discontinued.

24
25 *Information on Resources for Developmental Screening*

26 CCDBG Act §658E(c)(2)(E)(ii) requires that states provide eligible parents with information on
27 existing resources and other services in the state that conduct developmental screening and
28 provide referrals to services, when appropriate, for children eligible for subsidized child care
29 regarding:

- 30 --the Medicaid Early and Periodic Screening, Diagnosis, and Treatment program; and
31 --Early Childhood Intervention (ECI) and Preschool Program for Children with Disabilities
32 developmental screening services.

33
34 Information on developmental screenings must also include a description of how a family or
35 eligible child care provider can use available resources and services to obtain developmental
36 screenings for children receiving assistance who may be at risk for cognitive or other
37 developmental delays, which may include social, emotional, physical, or linguistic delays.

38
39 NPRM §98.33(c) clarifies that the developmental screening information should be made
40 available to parents as part of the intake process and to providers through training and education.

41
42 Consistent with CCDBG Act §658E(c)(2)(E)(ii) and NPRM §98.33(c), §809.15(b) is amended to
43 add the requirement, pursuant to CCDBG Act §658E(c)(2)(E)(ii), that Boards include:

44 --information on resources and services available in the local workforce development area for
45 conducting developmental screenings and providing referrals to services when appropriate for
46 children eligible for child care services, including the use of:

- 47 --the Early and Periodic Screening, Diagnosis, and Treatment program under 42 U.S.C.
48 1396 et seq.; and

1 --developmental screening services available under Part B and Part C of the Individuals
2 with Disabilities Education Act (20 U.S.C. 1419, 1431 et seq.); and
3 --a link to the Agency's designated child care consumer education website.
4

5 The Commission clarifies that Boards are not required to make referrals or to ensure that
6 developmental screenings are conducted. The only requirement is that Boards provide
7 information to parents regarding available local resources and developmental screenings.
8

9 Additional information and guidance regarding the manner in which information on
10 developmental screenings is made available will be provided by the Agency through updates to
11 the Child Care Services Guide. Additionally, the Agency is working with statewide training
12 partners regarding making training and education on developmental screenings available to
13 providers.
14

15 The Commission also notes that this provision does not affect the rules, policies, and procedures
16 currently in place regarding approval of the inclusion rate pursuant to §809.20(e).
17

18 *Consumer Education*

19 CCDBG Act §658E(c)(2)(E) and NPRM §98.33 require that states collect and disseminate
20 consumer education information to parents of eligible children, the general public, and, where
21 applicable, providers regarding:

- 22 --availability of the full diversity of child care services;
 - 23 --quality of providers;
 - 24 --state processes for licensing, conducting background checks, and monitoring child care
25 providers;
 - 26 --other programs for which families that receive child care services may be eligible;
 - 27 --research and best practices concerning children's development; and
 - 28 --state policies regarding social-emotional behavioral health of children.
- 29

30 Additional information and guidance regarding the manner in which consumer education
31 information is made available will be provided by the Agency through updates to the Child Care
32 Services Guide, including guidance on:

- 33 -- providing licensing compliance information;
 - 34 --making consumer education information available in printed form; and
 - 35 --ensuring consumer education information is accessible to both individuals with disabilities and
36 individuals with limited English proficiency.
- 37

38 Additionally, NPRM §98.33(d) requires that parent consumer education information also
39 include:

- 40 --licensing compliance information of the provider selected by the parent;
 - 41 --how to submit a complaint regarding a child care provider;
 - 42 --how to contact community resources that assist parents in locating quality child care; and
 - 43 --how CCDF subsidies are designed to promote equal access to the full range of child care
44 providers.
- 45

46 All consumer education required by the final CCDF regulations is available on the Texas Child
47 Care Solutions website at www.texaschildcaresolutions.org.
48

1 Section 809.15 is amended to require that Boards provide a link to the Commission's designated
2 child care consumer education website as part of the consumer education information provided
3 to parents.

4
5 **§809.16. Quality Improvement Activities**

6 Section 809.16 is amended to remove outdated CCDF regulatory citations. The current CCDF
7 regulations are being amended by the U.S. Department of Health and Human Services and the
8 NPRM language has changed citations for quality improvement activities and the use of CCDF
9 for construction. Further, the list of allowable quality activities in the CCDF regulations has
10 been expanded to include quality activities listed in the CCDBG Act. Section 809.16 removes
11 the specific citations list of quality activities, and replaces it with the general reference for CCDF
12 in 45 C.F.R., Part 98.

13
14 **§809.17. Leveraging Local Resources**

15 Section 809.17 is amended with language moved, without changes, from Subchapter C
16 §809.42(c) related to public entities certifying expenditures for direct child care, as the language
17 is more relevant to the local match process described in §809.17 than to eligibility for child care
18 services described in §809.42(c).

19
20 **§809.19. Assessing the Parent Share of Cost**

21
22 *Parent Share of Cost Incentives to Consider Selection of a TRS-Certified Provider*

23 NPRM §98.30(h) includes provisions designed to provide parents with incentives that
24 encourage the selection of high-quality child care without violating parental choice
25 provisions. The NPRM provides states with flexibility in determining what types of
26 incentives to use to encourage parents to choose high-quality providers, including the option
27 to lower the parent share of cost for parents who choose a high-quality provider.

28
29 Consistent with NPRM §98.30(h) and to encourage parents to select a TRS-certified provider as
30 well as encourage greater provider participation in the TRS program, the Commission amends
31 §809.19(a)(1) to allow Boards to consider the parent selection of a TRS-certified provider in the
32 parent share of cost assessment.

33
34 *Parent Share of Cost during the 12-Month Eligibility Period*

35 To support continued care throughout the 12-month eligibility period, NPRM §98.21(a)(3):

36 --prohibits states from increasing the parent share of cost during the 12-month eligibility period,
37 regardless of increases in the family income; and

38 --requires that states act upon information provided by the parent that would result in a reduction
39 in the parent share of cost.

40
41 Consistent with the NPRM, §809.19(a) is amended to add the requirement that the parent share
42 of cost is assessed only at the following times:

43 --Initial eligibility determination;

44 --12-month eligibility redetermination;

45 --The addition of a child in care that would result in an additional amount of parent share of cost;
46 and

47 --Parent's report of change in income, family size, or number of children in care that would result
48 in a reduced parent share of cost assessment.

1
2 *Basing the Parent Share of Cost on the Cost of Care or Subsidy Amount*

3 NPRM §98.45(k)(2) requires that the parent share of cost be based on income and the size of the
4 family and may be based on other factors as appropriate, but may not be based on the cost of care
5 or amount of the subsidy payment.
6

7 Section 809.19 is amended to remove the provision that the assessed parent share of cost must
8 not exceed the Board's maximum reimbursement rate or the provider's published rate, whichever
9 is lower. This provision is contrary to the requirement in the NPRM that the assessed parent
10 share of cost must not be based on the cost of care or the amount of the subsidy payment.
11

12 The parent share of cost must only be based on the following factors:

13 --the family's size and income, and

14 --may also consider the number of children in care and parent selection of a TRS-certified
15 provider as described in §809.19(a)(1)(B).
16

17 The Commission retains the rule language in §809.19(d) that allows Boards to review the
18 assessed parent share of cost for possible reduction if there are extenuating circumstances that
19 jeopardize a family's self-sufficiency. However, this reduction shall not be based on the Board's
20 maximum reimbursement rate or the provider's published rate.
21

22 The Commission notes that the current rules at §809.19(d) allow Boards to review the assessed
23 parent share of cost for possible reductions if there are extenuating circumstances that jeopardize
24 a family's self-sufficiency. Extenuating circumstances include unexpected temporary costs such
25 as medical expenses and work-related expenses that are not reimbursed by the employer. The
26 Commission is aware that some Boards may allow a limited number of these reductions during
27 the eligibility period. Such policies are still allowed, but Boards must ensure that the parent
28 share of cost is reduced any time the parent reports a change in income, family size, or number of
29 children in care that would result in a reduced parent share of cost.
30

31 The Commission further notes that amended §809.73 requires that parents report such changes
32 within 14 calendar days of the change. Changes in the parent share of cost should be made at the
33 beginning of the month following the reported change. If the parent does not report the change
34 within that time period, the Board is not required to make the change retroactive from the actual
35 date of the reduction.
36

37 The Commission is also aware that some Boards reduce the parent share of cost for a limited
38 period of time during the initial eligibility period in order to assist the parent, particularly newly
39 employed parents, with the parent share of cost. This remains an allowable practice under
40 §809.19(d) regarding a reduction of the assessed parent share of cost. After this initial reduction,
41 the parent share of cost may be regularly assessed based on the family size and income and
42 number of children in care, as required by §809.19(a)(1)(B).
43

44 *Exemptions for Parents of Children Experiencing Homelessness*

45 CCDBG Act §650E(3)(B)(i) and NPRM §98.46(a)(3) and §98.51 require that states give priority
46 for services to children experiencing homelessness. The NPRM preamble clarifies that Lead
47 Agencies have flexibility as to how they offer priority to these populations, including by

1 prioritizing enrollment, waiving copayments, paying higher rates for access to higher-quality
2 care, or using grants or contracts to reserve slots for priority populations.

3
4 Section 809.19(a)(2) is amended to require that parents of a child experiencing homelessness be
5 exempt from the parent share of cost.

6
7 The Commission emphasizes that pursuant to §809.19(e), the Board or its child care contractor
8 shall not waive the assessed parent share of cost unless the parent is covered by an exemption
9 specified in §809.19(a)(2).

10 11 **§809.20. Maximum Provider Reimbursement Rates**

12 Section 809.20(b) is amended to remove the requirement that Boards establish enhanced
13 reimbursement rates for preschool-age children at providers that obtain school readiness
14 certification, as the school readiness certification system has been discontinued.

15
16 Section 809.20(c) is amended to remove the September 1, 2015, effective date for the TRS tiered
17 reimbursement rates as these requirements are currently in effect.

18
19 Section 809.20(d) is amended to clarify in rule language the current requirement and practice
20 that there must be a 2 percentage point difference between the TRS star levels.

21 22 **SUBCHAPTER C. ELIGIBILITY FOR CHILD CARE SERVICES**

23 **The Commission proposes the following amendments to Subchapter C:**

24 25 **§809.41. A Child's General Eligibility for Child Care Services**

26 CCDBG Act §658E(c)(2)(N)(i) requires that each child who receives CCDF assistance be
27 considered to meet all eligibility requirements and receive assistance for not less than 12 months
28 before eligibility redetermination. NPRM §98.20 clarifies that general eligibility requirements
29 are applicable "at the time of eligibility determination or redetermination."

30
31 Consistent with CCDBG Act §658E(c)(2)(N)(i) and NPRM §98.20, §809.41 is amended to add
32 language clarifying that a child's general eligibility requirements--i.e., child's age, citizenship
33 status, and residency, and the family's income, work status, and attendance in a job training or
34 educational activity--are applied at the time of eligibility determination or redetermination.
35 Changes to the child's age or residency, the family's income, participation in work, job training,
36 or education activities that occur during the 12-month eligibility period and affect the child's
37 continued care and eligibility are covered in §809.42.

38
39 The CCDBG Act revised the definition of eligibility at §658P(4)(B) so that, in addition to being
40 at or below 85 percent of SMI for a family of the same size, the "family assets do not exceed
41 \$1,000,000 (as certified by a member of such family)." This requirement is included in NPRM
42 §98.20(a)(2)(ii).

43
44 Section 809.41(a)(3)(A) is amended to include this requirement and clarify that a family member
45 must certify that the family assets do not exceed the \$1,000,000 threshold. This certification will
46 be based on the parent's self-attestation and will be included in the application for services.
47 Boards are not required to verify this certification; however, if it is discovered that the family
48 may exceed the \$1,000,000 asset threshold, the parent may be subject to fraud fact-finding

1 procedures, as described in Subchapter F. Additional guidance will be provided in the Child
2 Care Services Guide.

3
4 As mentioned previously, CCDBG Act §650E(3)(B)(i) and NPRM §98.46(a)(3) and §98.51
5 require states to give priority for services to children experiencing homelessness. The NPRM
6 preamble clarifies that Lead Agencies have flexibility as to how they offer priority to these
7 populations.

8
9 Consistent with this requirement, §809.41(a)(2)(A) is amended to include language that
10 families meeting the definition of experiencing homelessness in §809.2 are considered as
11 having income that does not exceed 85 percent of the state median income. Therefore,
12 Boards are not required to conduct income eligibility determinations for families with a child
13 experiencing homelessness.

14
15 Section 809.41 is amended to remove subsection (d) related to job search limitations. Continued
16 child care for job search is described in §809.51.

17
18 CCDBG Act §658E(c)(2)(N)(iv) requires Lead Agencies to have a "Graduated Phaseout of
19 Eligibility" that includes policies and procedures to continue child care assistance at the time of
20 redetermination for children of parents who are working or attending a job training or
21 educational program and whose income has risen above the Lead Agency's initial income
22 eligibility threshold to qualify for assistance but remains at or below 85 percent of SMI.

23
24 NPRM §98.21(b) provides two options for states to use for the CCDBG Act's graduated phaseout
25 requirement. The phaseout can be accomplished either by:

26 --establishing a second tier of eligibility at 85 percent of SMI if the parents, at the time of
27 redetermination, are working or attending a job training or educational program, even if their
28 income exceeds the initial income limit; or

29 --using the approach specified above, but only for a limited period of not less than an additional
30 12 months.

31
32 Section 809.41 is amended to add language requiring that Boards that establish initial family
33 income eligibility at a level less than 85 percent of the SMI must ensure that the family remains
34 income-eligible for care after passing the Board's initial income eligibility limit. As a result, for
35 Boards with an initial eligibility limit lower than 85 percent of the SMI, the family's income
36 eligibility for continued care will be 85 percent of the SMI at the following times:

37 --at the 12-month redetermination;

38 --once a parent resumes activities during the three-month period described in §809.51; and

39 --any time a parent reports a change in income that may exceed 85 percent of the SMI.

40
41 This language is consistent with NPRM §98.21(b)(1)(i), which provides the option to require that
42 the family remain income-eligible for care after passing the initial income eligibility limit,
43 including at the family's scheduled 12-month eligibility redetermination, as long as the family
44 income does not exceed 85 percent of SMI.

45
46 In determining if the family exceeds 85 percent of the SMI, the Board will use income
47 calculation methodology and guidance that take into consideration fluctuations of income
48 pursuant to §809.44(a).

1
2 The Commission notes that Boards are not required to establish initial family income eligibility
3 at a level less than 85 percent of the SMI. The graduated phaseout requirements only apply to
4 Boards that have established income eligibility thresholds pursuant to §809.41(a) that are less
5 than 85 percent of the SMI.
6

7 **§809.42. Eligibility Verification, Determination, and Redetermination**

8 Section 809.42 is amended to include rule provisions related to eligibility verification,
9 determination, and redetermination consistent with the CCDBG Act.
10

11 Section 809.42(a) is amended to emphasize that a Board shall ensure that all eligibility
12 requirements for child care are verified prior to authorizing care. Due to the requirement in
13 CCDBG Act §658E(c)(2)(N)(i) that each child who receives CCDF assistance will be considered
14 to meet all eligibility requirements and will receive assistance for not less than 12 months before
15 the eligibility is redetermined, it is critical that eligibility is properly and accurately verified prior
16 to authorizing care.
17

18 Consistent with CCDBG Act §658E(c)(2)(N)(i) and NPRM §98.21, amended §809.42(b)
19 requires that Boards ensure that eligibility for child care services shall be redetermined no sooner
20 than 12 months following the initial determination or most recent redetermination.
21

22 **§809.43. Priority for Child Care Services**

23 Consistent with CCDBG Act §650E(3)(B)(i) and NPRM §§98.46(a)(3) and 98.51, which require
24 states to give priority for services to children experiencing homelessness, the Commission
25 amends §809.43 to add children experiencing homelessness as a second priority group served,
26 subject to the availability of funds. This priority group will follow the three priority groups in
27 state statute--children in protective services, children of a qualified veteran or spouse, and
28 children of foster youth.
29

30 **§809.44. Calculating Family Income**

31 CCDBG Act §658E(c)(2)(N)(i)(II) and NPRM §98.21(c) require that states take into
32 consideration irregular fluctuations of earnings when calculating income for eligibility. The
33 NPRM further clarifies this requirement by adding that the calculation of income policies
34 ensures that temporary increases in income, "including temporary increases that result in
35 monthly income exceeding 85 percent of SMI (calculated on a monthly basis), do not affect
36 eligibility or family co-payments."
37

38 Section 809.44(a) is amended to reflect these new requirements. The rule language requires that
39 Boards ensure family income is calculated in accordance with Commission guidelines.

40 Consistent with the CCDBG Act, rule language also requires that Commission guidelines:

41 --take into account irregular fluctuations in earnings; and

42 --ensure that temporary increases in income, including temporary increases that result in monthly
43 income exceeding 85 percent SMI, do not affect eligibility or parent share of cost.
44

45 A standard and uniform methodology applied consistently across all 28 local workforce
46 development areas (workforce areas) is important to ensure that the state is meeting the
47 requirements of the CCDBG Act regarding fluctuations of income. This is also important, as
48 child care is also required to continue if a parent moves to another workforce area.

1
2 The Commission will be developing guidelines based on the current methodology and income
3 sources used by the Workforce Innovation and Opportunity Act of 2014 (WIOA) adult program.
4 WIOA annualizes family income using the most recent six months of income sources. By taking
5 into consideration six months of income, this methodology meets the requirement to take into
6 account irregular fluctuations in earnings and will ensure that temporary increases in monthly
7 income do not affect eligibility or parent share of cost. Additionally, aligning the child care
8 income calculation sources and methodology with sources and methodology used by WIOA will
9 provide consistency among the Commission's two major programs in which income is calculated
10 for eligibility purposes.

11
12 The guidelines will identify any differences between the two programs that are specific to the
13 relevant program, while retaining the overall goal of aligning the income calculation
14 methodology as closely as possible, given any federal guidance specific to the programs. The
15 guidance will include, but not be limited to, the following:

- 16 --Income documentation requirements at initial eligibility that may differ from requirements at
17 redetermination;
- 18 --Documentation requirements for gaps in income;
- 19 --Calculation of bonuses received during the 12-month eligibility period;
- 20 --The methodology and documentation used to determine family income for changes reported
21 during the 12-month eligibility period; and
- 22 --The methodology and documentation used to determine family income for parents who resume
23 work, training, or education during the three-month period of nontemporary cessation of
24 activities.

25
26 Section 809.44(b) is amended to provide an updated itemized list of income sources that are
27 specifically excluded from determining family income. This list includes income sources that
28 are specifically excluded by various federal laws or regulations in determining eligibility for
29 public assistance programs including CCDF, as well as income sources that are excluded by the
30 WIOA adult program.

31
32 The specific exclusions are:

- 33 --Medicare, Medicaid, Supplemental Nutrition Assistance Program (SNAP) benefits, school
34 meals, and housing assistance;
- 35 --Monthly monetary allowances provided to or for children of Vietnam veterans born with
36 certain birth defects;
- 37 --Needs-based educational scholarships, grants, and loans, including financial assistance under
38 Title IV of the Higher Education Act--Pell Grants, Federal Supplemental Educational
39 Opportunity grants, Federal Work Study Program, PLUS, Stafford loans, and Perkins loans;
- 40 --Individual Development Account (IDA) withdrawals for the purchase of a home, medical
41 expenses, or educational expenses;
- 42 --Onetime cash payments, including tax refunds, Earned Income Tax Credit (EITC) and
43 Advanced EITC, onetime insurance payments, gifts, and lump sum inheritances;
- 44 --VISTA and AmeriCorps living allowances and stipends;
- 45 --Noncash or in-kind benefits such as employer-paid fringe benefits, food, or housing received in
46 lieu of wages;
- 47 --Foster care payments and adoption assistance;

- 1 --Special military pay or allowances, including subsistence allowances, housing allowances,
- 2 family separation allowances, or special allowances for duty subject to hostile fire or imminent
- 3 danger;
- 4 --Income from a child in the household between 14 and 19 years of age who is attending school;
- 5 --Early withdrawals from qualified retirement accounts specified as hardship withdrawals as
- 6 classified by the Internal Revenue Service (IRS);
- 7 --Unemployment compensation;
- 8 --Child support payments;
- 9 --Cash assistance payments, including Temporary Assistance for Needy Families (TANF),
- 10 Supplemental Security Income (SSI), Refugee Cash Assistance, general assistance, emergency
- 11 assistance, and general relief;
- 12 --Onetime income received in lieu of TANF cash assistance;
- 13 --Income earned by a veteran while on active military duty and certain other veterans' benefits,
- 14 such as compensation for service-connected death, vocational rehabilitation, and education
- 15 assistance;
- 16 --Regular payments from Social Security, such as Old-Age and Survivors Insurance Trust Fund;
- 17 --Lump sum payments received as assets in the sale of a house, in which the assets are to be
- 18 reinvested in the purchases of a new home (consistent with IRS guidance);
- 19 --Payments received as the result of an automobile accident insurance settlement that are being
- 20 applied to the repair or replacement of an automobile; and
- 21 --Any income sources specifically excluded by federal law or regulation.

22
23 The Commission understands that the new income calculation methodology and income
24 exemptions may equate to lower parent share of cost assessments, thereby increasing the cost of
25 care and reducing the number of children the Board may be able to serve. The Agency will
26 continue to analyze Board costs, including parent share of cost, as part of the Agency's
27 performance target methodology.

28
29 New §809.44(c) states that income that is not listed in §809.44(b) as excluded from income is
30 included as income.

31
32 **§809.45. Choices Child Care**
33 Section 809.45(b) is amended to clarify that for a parent receiving Choices Child Care who
34 ceases participation in the Choices program during the 12-month eligibility period, Boards must
35 ensure that:

- 36 --child care continues for the three-month period pursuant to §809.51; and
- 37 --the provisions of §809.51 shall apply if the parent resumes participation in Choices or begins
- 38 participation in work or attendance in a job training or education program during the three-month
- 39 period.

40
41 **§809.46. Temporary Assistance for Needy Families Applicant Child Care**
42 Section 809.46 is amended to remove provisions that:
43 --duplicate the 12-month eligibility period specified in §809.42; or
44 --would end care prior to the end of the 12-month eligibility period.

45
46 **§809.47. Supplemental Nutrition Assistance Program Employment and Training Child**
47 **Care**

1 Section 809.47 is amended to remove language stating that SNAP Employment and Training
2 (SNAP E&T) care continues as long as the case remains open.

3
4 Section 809.47(b) is added to clarify that for a parent receiving SNAP E&T Child Care who
5 ceases participation in the E&T program during the 12-month eligibility period, Boards must
6 ensure that:

7 --child care continues for the three-month period pursuant to §809.51; and

8 --the provisions of §809.51 shall apply if the parent resumes participation in the E&T program or
9 begins participation in work or attendance in a job training or education program during the
10 three-month period.

11
12 **§809.48. Transitional Child Care**

13 Section 809.48 is amended to remove provisions that would end care prior to the end of the 12-
14 month eligibility period.

15
16 **§809.49. Child Care for Children Receiving or Needing Protective Services**

17 Section 809.49 is amended to clarify that child care discontinued by DFPS prior to the end of the
18 12-month eligibility period shall be subject to the Continuity of Care provisions in §809.54.

19
20 Section 809.49 is also amended to clarify that the requirements of §809.91(f)(1) do not apply to
21 foster parents whose care is authorized by DFPS. The language clarifies that requests made by
22 DFPS for specific eligible providers are enforced for children in protective services, including
23 children of foster parents when the foster parent is the owner, director, assistant director, or other
24 individual with an ownership interest in the provider.

25
26 A technical change to §809.49(a)(2) is made to clarify that DFPS may authorize care for a child
27 under the age of 19.

28
29 **§809.50. At-Risk Child Care**

30 Section 809.50 is amended to clarify that eligibility requirements for At-Risk child care are
31 applied at initial determination and at the 12-month eligibility redetermination, pursuant to
32 §809.41 and §809.42.

33
34 **§809.51. Child Care during Interruptions in Work, Education, or Job Training**

35 Section 809.51 is amended to include CCDBG Act and NPRM requirements regarding the
36 provision of child care during interruptions in work, education, or job training. The section
37 contains the rules related to both temporary interruptions and permanent cessation of activities
38 during the 12-month eligibility period.

39
40 Section 809.51(a) is amended to include the CCDBG Act requirement that if a child met all of
41 the applicable eligibility requirements for any child care service in Subchapter C on the date of
42 the most recent eligibility determination or redetermination, the child shall be considered to be
43 eligible and will receive services during the 12-month eligibility period, regardless of any:
44 --change in family income, if that family income does not exceed 85 percent of SMI for a family
45 of the same size; or
46 --temporary change in the ongoing status of the child's parent as working or attending a job
47 training or education program.

1 Consistent with language in the NPRM, a temporary change shall include, at a minimum, any:
2 --time-limited absence from work for an employed parent for periods of family leave (including
3 parental leave) or sick leave;
4 --interruption in work for a seasonal worker who is not working between regular industry work
5 seasons;
6 --student holiday or break for a parent participating in training or education;
7 --reduction in work, training or education hours, as long as the parent is still working or
8 attending a training, or education program;
9 --other cessation of work or attendance in a training or education program that does not exceed
10 three months;
11 --change in age, including turning 13 years old during the eligibility period; and
12 --change in residency within the state.

13
14 Section 809.51(b) is amended to require that during the period of time between eligibility
15 redeterminations, a Board shall discontinue child care services due to a parent's loss of work or
16 cessation of attendance at a job training or educational program that does not constitute a
17 temporary change in accordance with paragraph (b)(2) of this section. However, Boards must
18 ensure that care continues at the same level for a period of not less than three months after such
19 loss of work or cessation of attendance at a job training or educational program.

20
21 Section 809.42(c) is amended to state that if a parent resumes work or attendance at a job
22 training or education program at any level and at any time during the three months, Boards shall
23 ensure that:

24 --care will continue to the end of the 12-month eligibility period at the same or greater level,
25 depending upon any increase in the activity hours of the parent; and
26 --the parent share of cost will not be increased during the remainder of the 12-month eligibility
27 period, including for parents who are exempt from the parent share of cost pursuant to §809.19.

28
29 This is consistent with NPRM §98.21(a)(3), which prohibits states from increasing the parent
30 share of cost during the 12-month eligibility period, regardless of increases in the family income.

31
32 The rule language also clarifies that the Board child care contractor shall verify only:
33 --that the family income does not exceed 85 percent SMI; and
34 --the resumption of work or attendance at a job training or education program.

35 36 *School Holidays and Breaks*

37 The Commission clarifies that student holidays such as spring break and breaks between
38 semesters that are less than three months are considered temporary changes, and eligibility shall
39 continue during those breaks. Breaks between semesters that last longer than three months are
40 considered nontemporary, and care ends if the parent does not resume attendance at an education
41 or job training program, or does not participate in work within three months of the end of the
42 semester.

43 44 *Reductions in Work, Training, or Education for Dual-Parent Families*

45 The Commission clarifies that in a dual-parent family, if both parents have a nontemporary loss
46 of job (or end of training/education activities), then the family would be subject to the three-
47 month job search period prior to termination. However, if one parent experiences a
48 nontemporary change, then this would be considered a reduction in the dual-parent 50-hour

1 participation requirements. Under the CCDBG Act, a reduction in work is not considered a
2 permanent loss of job and is not subject to discontinuation of the child's care. Care would
3 continue through the 12-month period without requiring care to end if one parent does not
4 resume activities within three months. The child is still residing with at least one parent who is
5 working and is still eligible under the CCDBG Act.

6
7 *Continued Care for Children over the Age of 13*

8 The Commission notes that the DFPS Child Care Licensing allows children under the age of 14
9 (and under the age of 19 for children with disabilities) to receive care at a regulated facility.
10 However, the Commission is aware that some child care facilities do not serve children over the
11 age of 13. In such a case, the Board must ensure that eligibility continues at a different provider
12 selected by the parent until the end of the child's eligibility period, unless the parent voluntarily
13 withdraws from child care services.

14
15 *Continued Care for Children and Families Relocating to Another Workforce Area*

16 Under the CCDBG Act, a change in the child's residence is not grounds for ending care in the
17 state, regardless of the enrollment status of the workforce area to which the parent moved. The
18 Commission understands that a Board at full enrollment would be required to enroll and fund
19 children even if the Board enrollment of new children is closed at the time. The movement of
20 children both into and out of workforce areas is anticipated to be balanced throughout the year.
21 However, the Agency will track this movement and the fiscal impact on Boards to determine if
22 funding amounts should be adjusted accordingly.

23
24 Additional policies, procedures, and documenting requirements regarding continuation of care
25 for children and families who relocate to another workforce area will be provided as updates to
26 the Child Care Services Guide.

27
28 The Commission clarifies that the Board that determined eligibility at the beginning of the 12-
29 month period is responsible for any subsequent finding of improper eligibility determinations.
30 However, the Board in the workforce area in which the family relocates is responsible for
31 verifying that the move did not result in a nontemporary loss of work, training, or education, and
32 the family is not over 85 percent of the SMI.

33
34 The Commission clarifies that if the move to a different workforce area does not result in a
35 change of provider (i.e., the child remains at the originating workforce area provider), then care
36 would continue at that provider under the originating Board's agreement, rates, and funding
37 through the remainder of the authorization for care and the end of the 12-month eligibility
38 period. However, if the move to a different workforce area results in or is accompanied by a
39 change in provider, then the receiving Board will establish and fund the authorization.

40
41 The Commission also clarifies that if a parent is participating in the three-month period of
42 continued care and relocates to a different workforce area without resuming activities, then the
43 parent would not receive a new three-month period, but is entitled to continue the three-month
44 period that began in the previous workforce area.

45
46 *Other Cessation of Work, Training, or Education Activities*

47 The Commission recognizes that there are situations, such as parent incarcerations or other
48 circumstances, that may not be clearly defined in the rules. The Commission will work with

1 Boards to provide guidance on these situations. As a general rule, if the separation from
2 activities is of a length that would allow the parent to continue participation within three months,
3 then care would continue through the remainder of the 12-month eligibility period. If, however,
4 the separation is expected to last over three months, then care would be discontinued three
5 months after the cessation of work, training, or education.

6
7 *Number of Three-Month Periods in a 12-Month Eligibility Period*

8 The CCDBG Act requires that care continue for at least 12 months following the initial
9 eligibility determination. Neither the CCDBG Act nor the NPRM allows states to put limits on
10 the number of three-month periods of continued care that a parent may have during the 12-month
11 eligibility period. Parents will be allowed a three-month period of continued care for each
12 nontemporary cessation of activities within the 12-month eligibility period.

13
14 *Parent Share of Cost during the Three-Month Period of Continued Care*

15 As required in §809.19(a)(1)(c), the parent share of cost is reassessed if a parent reports a change
16 in income that would result in a reduced parent share of cost. Accordingly, the parent share of
17 cost should be reassessed during the three-month period due to the resulting reduction of family
18 income. As mentioned in the discussion on calculating family income in §809.44, the
19 Commission will provide guidance on the methodology used to calculate income during this
20 period in order to take into consideration fluctuation in income. During this period, Boards may
21 also reduce the parent share of cost based on the Board policies for reductions due to extenuating
22 circumstances pursuant to §809.19(d).

23
24 *Increases in the Level of Care following the Three-Month Period of Continued Care*

25 Section 809.51(c) requires care to continue to the end of the 12-month eligibility period at the
26 same or greater level, depending on any increase in the activity hours of the parent. The
27 Commission expects that the parent should provide documentation to verify that such an increase
28 is warranted.

29
30 *Implementation of the 12-Month Eligibility Period*

31 The Commission clarifies that eligibility determinations under the new rules will go into effect at
32 the family's first scheduled redetermination (under the Board's previous determination period)
33 following October 1, 2016.

34
35 **§809.52. Child Care for Children Experiencing Homelessness**

36 New §809.52 is added to include initial eligibility for children experiencing homelessness.
37 CCDBG Act §658E(c)(3) requires that state procedures permit enrollment (after an initial
38 eligibility determination) of children experiencing homelessness while required documentation is
39 obtained.

40
41 Consistent with this requirement, §809.52(a) requires that for a child experiencing homelessness,
42 a Board shall ensure that the child is initially enrolled for a period not to exceed three months.

43
44 Section 809.52(b)(1) states that if, during the three-month enrollment period, the parent of a
45 child experiencing homelessness is unable to provide documentation verifying that the child
46 meets the age and citizenship status requirements under §809.41(a)(1) - (2), then care shall be
47 discontinued following the three-month enrollment period. Consistent with NPRM §98.51,

1 payments of child care services for this three-month period are not considered improper
2 payments.

3
4 Section 809.52(b)(2) states that if, during the three-month enrollment period, a parent provides
5 documentation verifying eligibility under §809.41(a) (regarding the child's age and citizenship
6 status, and the parent's participation in work, job training, or education activities) then care shall
7 continue through the end of the 12-month initial eligibility period (inclusive of the three-month
8 initial enrollment period).

9
10 For parents of children experiencing homelessness, parent self-attestation of the eligibility
11 requirements under §809.41(a)(1) - (2) will be allowed for the first three months for all eligibility
12 requirements, as long as the family meets the definition of homelessness. This can be verified
13 through another entity such as a school district or housing authority, or by the Board contractor.

14
15 The Agency will work with Boards to provide guidance on determining initial and continuing
16 eligibility for homeless families.

17
18 The Commission clarifies that parents of children experiencing homelessness must have appeal
19 rights pursuant to §809.74.

20
21 **§809.53. Child Care for Children Served by Special Projects**

22 Section 809.53 is amended to clarify that the provisions related to child care for children serviced
23 by special projects are only for special projects funded through non-CCDF sources.

24
25 **§809.54. Continuity of Care**

26 Section 809.54 is amended to clarify that for enrolled children, including children whose
27 eligibility for Transitional child care has expired, care continues through the end of the
28 applicable eligibility periods described in §809.42.

29
30 Rule language also clarifies that enrolled children of military parents in military deployment
31 remain eligible for continued care, including parents in military deployment at the end of the 12-
32 month eligibility redetermination period.

33
34 Section 809.54 also removes the temporary placement of a child if space is available due to
35 another child's absence due to custody arrangements, as temporary placements are contrary to the
36 CCDBG Act's 12-month eligibility requirements.

37
38 **§809.55. Mandatory Waiting Period for Reapplication**

39 Section 809.55, regarding a mandatory waiting period for reapplication if care is terminated for
40 certain reasons, is repealed because the listed termination reasons for ending care are no longer
41 applicable.

42
43 **SUBCHAPTER D. PARENT RIGHTS AND RESPONSIBILITIES**

44 **The Commission proposes the following amendments to Subchapter D:**

45
46 **§809.71. Parent Rights**

1 Section 809.71 is amended to clarify that the 20-day eligibility notification following receipt of
2 eligibility documentation from the parent is applicable for both the initial eligibility
3 determinations and the 12-month eligibility redetermination.

4
5 Section 809.71(9) is amended to remove the exceptions to the 15-day notification of termination
6 for instances in which care is to end immediately due to a parent no longer participating in
7 Choices or SNAP E&T or due to a child being absent five consecutive days, as these are no
8 longer eligible reasons to terminate care during the 12-month eligibility period.

9
10 Regarding the 15-day termination notice, the Commission clarifies that for parents with a
11 nontemporary cessation of activities, at a minimum, notification must be provided at least 15
12 days prior to the end of the three-month period of continued care. However, Boards should also
13 clearly notify or provide clear instructions to parents at the beginning of the three-month period
14 that care will end if the parent does not resume participation at any level within three months.

15
16 Section 809.71 is amended to remove the 30-day notification due to terminations to make room
17 for a priority group member, as this is no longer an eligible reason to terminate care during the
18 12-month period.

19
20 Section 809.71 is also amended to remove the requirement that parents be informed of the
21 Board's attendance policies. Notification of the attendance standards are located in amended
22 §809.78.

23 24 **§809.72. Parent Eligibility Documentation Requirements**

25 Section 809.72(a) is amended to clarify that child care cannot be determined or redetermined and
26 care cannot be authorized until parents provide to the Board's child care contractor all the
27 information necessary to determine eligibility.

28
29 Section 809.72(b) is amended to clarify that a parent's failure to submit documentation shall
30 result in initial denial of child care service or the termination of services at the 12-month
31 redetermination period.

32
33 As mentioned in §809.42(a), due to the requirement in CCDBG Act §658E(c)(2)(N)(i) that each
34 child who receives CCDF-funded child care will be considered to meet all eligibility
35 requirements and will receive assistance for not less than 12 months before the eligibility is
36 redetermined, it is critical that all eligibility documentation submitted is properly and accurately
37 verified prior to authorizing care. As described in §809.42(c), an exception to this requirement
38 exists for a child experiencing homelessness.

39 40 **§809.73. Parent Reporting Requirements**

41 CCDBG Act §658E(c)(2)(N)(ii) and NPRM §98.21(e)(2) state that any requirement for parents
42 to provide notification of changes in circumstances shall not constitute an undue burden on
43 families. Any such requirements shall:

- 44 --limit notification requirements to changes that impact a family's eligibility (e.g., only if income
- 45 exceeds 85 percent of SMI, or there is a nontemporary change in the status of the child's parent
- 46 as working or attending a job training or educational program) or changes that impact the Lead
- 47 Agency's ability to contact the family or pay providers;
- 48 --not require an office visit to fulfill notification requirements; and

1 --offer a range of notification options (e.g., phone, e-mail, online forms, extended submission
2 hours) to accommodate the needs of working parents.

3
4 Further NPRM language states that Lead Agencies must allow families the option to voluntarily
5 report changes on an ongoing basis:

6
7 --Lead Agencies are required to act on the information provided by the family if it would reduce
8 the family's copayment or increase the family's subsidy.

9 --Lead Agencies are prohibited from acting on information that would reduce the family's
10 subsidy unless the information provided indicates that the family's income exceeds 85 percent of
11 SMI for a family of the same size, taking into account irregular income fluctuations, or, at the
12 option of the Lead Agency, if the family has experienced a nontemporary change in work,
13 training, or educational status.

14
15 Section 809.73 related to parent reporting requirements is amended consistent with this guidance.

16
17 Section 809.73(a) is amended to require Boards to ensure that during the 12-month eligibility
18 period, parents are only required to report items that impact a family's eligibility or that enable
19 the Board or Board contractor to contact the family or pay the provider.

20
21 This is further clarified in §809.73(b), which is amended to state that parents shall report to the
22 child care contractor, within 14 days of the occurrence, the following:

23 --Changes in family income or family size that would cause the family to exceed 85 percent of
24 SMI for a family of the same size;

25 --Changes in work or attendance at a job training or educational program not considered to be
26 temporary changes, as described in §809.42; and

27 --Any change in family residence, primary phone number, or e-mail (if available).

28
29 The amendment extends the number of days to report from the current 10 calendar days to 15
30 calendar days. This will allow additional time for parents to report changes while also allowing
31 sufficient time for Boards to make any requested changes in the parent share of cost or for other
32 authorization changes to become effective, as well as sufficient time to adjust the parent's
33 eligibility (if the reported change caused the family to exceed 85 percent SMI or constitutes a
34 nontemporary change in activity status).

35
36 Because the CCDBG Act limits termination of eligibility for care to the parent's permanent
37 cessation of work, training, or education activities, or the family exceeding 85 percent of SMI
38 (taking into consideration fluctuations of income), §809.73 is also amended to remove the
39 provision that care may be terminated and costs may be recovered due to a parent failure to
40 report a change in §809.73(b). However, the provision that failure to report a change may result
41 in fact-finding for suspected fraud as described in Subchapter F is retained.

1 Section 809.73 is also amended to require Boards to allow parents to report, and require the child
2 care contractor to take appropriate action, regarding changes in:
3 --income and family size, which may result in a reduction in the parent share of cost pursuant to
4 §809.19; and
5 --work, job training, or education program participation that may result in an increase in the level
6 of child care services
7

8 The CCDBG Act requires that reporting requirements during the 12-month period do not
9 constitute an undue burden on working parents, and the NPRM clarifies that the reporting
10 requirements must only be on information that affects eligibility or the ability to contact the
11 parent and pay the provider. Therefore, the Commission emphasizes that Boards must not
12 require parents to report any changes during the 12-month period other than those specified in
13 amended §809.73(a) - (b).
14

15 The Agency will work with Boards to provide technical assistance on establishing clear and
16 family-friendly information for parents on when they are required to report income and family
17 changes.
18

19 Additionally, the Agency will work with Boards to provide reports and tools, including tools
20 associated with wage records and a child's attendance tracking, to assist Boards in identifying
21 parents and families that:

- 22 --may have changes in income or family size that may have resulted in the family income
23 exceeding 85 percent of the SMI; or
- 24 --may have experienced a nontemporary change in work, training, or education activities.
25

26 *Implementation of the Reporting Requirements*

27 The Commission clarifies that parents with children enrolled prior to the effective date of the
28 rule amendments may be notified of the new parent reporting requirements at the parent's next
29 scheduled redetermination. However, the standards for assessing any reported changes to the
30 parent's eligibility as well as changes in the consequences for failure to report will be effective on
31 the effective date of the amended rules. Therefore, the Board must ensure that if a parent fails to
32 report a change that was required under the former rules, care shall not be terminated and
33 recoupment is not required for this failure to report, subject to the requirements in Subchapter F
34 regarding recoupments.
35

36 **§809.74. Parent Appeal Rights**

37 Section 809.74 is amended to clarify that parents may appeal the amount of any recoupment
38 determined pursuant Subchapter F of this chapter.
39

40 **§809.75. Child Care during Appeal**

41 Section 809.75 is amended to remove the provisions for not continuing care during a parent
42 appeal as the reasons for terminating care provided in this section no longer apply.
43

44 **§809.76. Parent Responsibility Agreement**

45 As stated previously, CCDBG Act §658E(c)(2)(N) states that each child who receives assistance
46 will be considered to meet all eligibility requirements for such assistance and will receive such
47 assistance for not less than 12 months before the state redetermines eligibility.
48

1 NPRM §98.20(b)(4) clarifies that the state may establish additional eligibility conditions,
2 regarding the child's age, citizenship, residing in a family with an income that does not exceed 85
3 percent SMI, and residing with parents who are working or in job training or education, as long
4 as the additional requirements do not impact eligibility other than at the time of eligibility
5 determination or redetermination. Additionally, CCDBG Act §658E(c)(2)(N)(ii) and NPRM
6 §98.21(d) require that Lead Agency eligibility redetermination requirements do not unduly
7 disrupt parent work, training, or education activities.

8
9 The PRA in §809.76 requires that the parent shall:

10 --pursue child support by:

11 --cooperating with the Office of the Attorney General (OAG), if necessary, to establish
12 paternity and to enforce child support on an ongoing basis by either:

13 --providing documentation that the parent has an open case with OAG and is cooperating
14 with OAG; or

15 --opening a child support case with OAG and providing documentation that the parent is
16 cooperating with OAG; or

17 --providing documentation that the parent has an arrangement with the absent parent for child
18 support and is receiving child support on an ongoing basis;

19 --not use, sell, or possess marijuana or other controlled substances; and

20 --ensure that each family member younger than 18 years of age attend school regularly (unless
21 exempt under state law).

22
23 Current §809.76(c) requires that the parent demonstrate compliance with these provisions within
24 three months of initial eligibility. If the parent does not demonstrate compliance within three
25 months, child care is required to end. Some Boards require parents to demonstrate compliance
26 with the PRA at the time of initial eligibility.

27
28 Boards have reported that parents meet PRA requirements by opening an OAG case at initial
29 determination, closing the case immediately following initial determination, and then reopening
30 the case immediately prior to redetermination. This increases OAG's workload and requires
31 Boards and Board contractors to track parent compliance with the PRA—without meeting the
32 PRA's intent.

33
34 Therefore, §809.76 regarding the PRA is repealed, as the requirements of the provisions of the
35 PRA:

36 --cannot be applied or enforced during the 12-month eligibility period;

37 --cause delays in determining eligibility; and

38 --cause errors in calculating income due to inconsistent receipt of child support.

39
40 **§809.77. Exemptions from the Parent Responsibility Agreement**

41 Section 809.77 related to exemptions from the PRA is repealed.

42
43 **§809.78. Attendance Standards and Reporting Requirements**

44 CCDBG Act §658E(c)(2)(S) and NPRM §98.45(m) require implementation of provider payment
45 practices that:

46 --align with generally accepted payment practices for children who do not receive CCDF funds;
47 and

1 --support the fixed costs of providing child care services by delinking provider payments from a
2 child's occasional absences.

3
4 NPRM §98.45(m)(2) included four options that states may consider to meet the statutory
5 requirement to support the fixed costs of providing child care by delinking payments from a
6 child's occasional absence. The options include:

7 --paying providers based on a child's enrollment, rather than attendance;

8 --providing full payment to providers as long as a child attends for at least 85 percent of the
9 authorized time;

10 --providing full payment to providers as long as a child is absent for five or fewer days in a
11 four-week period; and

12 --requiring states that do not choose one of these three approaches to describe their approach
13 in the State Plan, including how the approach is not weaker than one of the three listed
14 above.

15
16 Currently, Chapter 809 requires Boards to establish a policy on attendance standards and
17 procedures regarding reimbursement to providers for absence days. Chapter 809 requires Boards
18 to terminate services if a child exceeds the Board-allowed number of paid absences during a
19 year. If care is terminated due to excessive absences, then the parent must wait 30 days before
20 reapplying for services.

21
22 Neither the CCDBG Act nor the NPRM grants states the authority to terminate care due to a
23 child not meeting the state's attendance standards.

24
25 As described in §809.93, consistent with the requirements in the CCDBG Act and the NPRM,
26 the Commission amends §809.93 to state that providers shall be reimbursed based on the child's
27 enrollment, rather than daily attendance.

28
29 However, in order to ensure that authorizations for reimbursement based on enrollments do not
30 result in underutilization of services, and to prevent the potential for waste, fraud, or abuse of
31 public child care funds, the Commission establishes statewide attendance standards designed to
32 encourage parents to fully use child care services.

33
34 Section 809.78(a)(1) is amended to require that parents shall be notified that the eligible child
35 shall attend on a regular basis consistent with the child's authorization for enrollment. Failure to
36 meet attendance standards may:

37 --result in suspension of care; and

38 --be grounds for determining that a change in the parent's participation in work, a job training, or
39 an education program has occurred and care may be terminated pursuant to the requirements in
40 §809.51(b).

41
42 Section 809.78(a)(2) establishes allowable attendance standards as fewer than:

43 --five consecutive absences during the month;

44 --ten total absences during the month; or

45 --forty-one absences in a 12-month period.

1 Section 809.78(a)(3) states that child care providers may end a child's enrollment with the
2 provider if the child does not meet the provider's established attendance policy. As will be
3 discussed in Subchapter E, regarding provider reimbursement based on enrollment, a child's
4 eligibility cannot end based on the number of absences. However, parents must be notified that a
5 provider is allowed to discontinue enrollment of the child at the provider facility if the child does
6 not meet attendance standards established by the provider.

7
8 Section 809.78(a) is also amended to remove the provisions that child care services may be
9 terminated for absences or misuse of attendance automation policies. However, the rules retain
10 the provisions that parents be notified that misuse of the automated attendance procedures is
11 grounds for a potential fraud determination.

12
13 The Commission acknowledges that the rule amendments related to enrollments and absences
14 will require substantial modifications to existing Board policies and procedures as well as
15 changes to the Agency's information and attendance automation systems. The Agency will work
16 with Boards regarding these changes and to develop necessary reports to assist Boards, parents,
17 and providers in tracking attendance.

18 **SUBCHAPTER E. REQUIREMENTS TO PROVIDE CHILD CARE**

19 **The Commission proposes the following amendments to Subchapter E:**

20 **§809.91. Minimum Requirements for Providers**

21
22 CCDBG Act §658E(c)(2)(K) requires annual unannounced inspections of all CCDF providers
23 for compliance with health, safety, and fire standards. Relative providers are exempt from this
24 requirement. By state statute, listed family homes are not inspected by DFPS child care
25 licensing (unless there is a report of abuse or neglect at the facility). Therefore, under the
26 CCDBG Act, nonrelative listed family homes are not eligible to provide CCDF services.
27 Therefore, §809.91(b) is amended to remove requirements for Boards choosing to allow
28 nonrelative listed homes as eligible child care providers as these providers are no longer eligible
29 to care for CCDF-subsidized children.

30
31
32 Section 809.91(f) is amended to clarify that foster parents who are also directors, assistant
33 directors, or have an ownership in the child care center, may receive reimbursement if authorized
34 by DFPS.

35 **§809.92. Provider Responsibilities and Reporting Requirements**

36 Section 809.92(b) is amended to remove the specific attendance reporting requirements for
37 providers to:

- 38 --document and maintain a list of each child's attendance and submit the list upon request;
- 39 --inform the Board when an enrolled child is absent; and
- 40 --inform the Board that a child has not attended the first three days of scheduled care.

41
42
43 The implementation of the child care attendance automation system eliminates the need for
44 providers to report this attendance to the Board. However, the Commission notes that removing
45 the requirement from Chapter 809 that providers document and maintain a list of each child's
46 attendance does not remove the DFPS child care licensing requirement for providers to maintain
47 a daily sign-in sheet for all children enrolled at the facility.

1 **§809.93. Provider Reimbursement**

2 As explained in §809.78 regarding a child's attendance standards, CCDBG Act §658E(c)(2)(S)
3 and NPRM §98.45(m) require implementation of provider payment practices that:

4 --align with generally accepted payment practices for children who do not receive CCDF funds;
5 and

6 --support the fixed costs of providing child care services by delinking provider payments from a
7 child's occasional absences.

8
9 NPRM §98.45(m)(2) included four options that states may consider to meet the statutory
10 requirement to support the fixed costs of providing child care by delinking payments from a
11 child's occasional absence. The options include:

12 --paying providers based on a child's enrollment, rather than attendance;

13 --providing full payment to providers as long as a child attends for at least 85 percent of the
14 authorized time;

15 --providing full payment to providers as long as a child is absent for five or fewer days in a
16 four-week period; and

17 --requiring states that do not choose one of these three approaches to describe their approach
18 in the State Plan, including how the approach is not weaker than one of the three listed
19 above.

20
21 Currently, Chapter 809 requires Boards to establish a policy on attendance standards and
22 procedures regarding reimbursement to providers for absence days. Chapter 809 requires Boards
23 to terminate services if a child exceeds the Board-allowed number of paid absences during a
24 year. If care is terminated due to excessive absences, then the parent must wait 30 days before
25 reapplying for services.

26
27 Neither the CCDBG Act nor the NPRM grants states the authority to terminate care due to a
28 child not meeting the state's attendance standards.

29
30 To ensure statewide consistency for families and statewide compliance to the requirements in
31 CCDBG Act §658E(c)(2)(S) and NPRM §98.45(m), §809.93 is amended to implement a
32 statewide policy that reimburses regulated providers based on the child's enrollment, rather than
33 daily attendance.

34
35 The rules retain the requirement that relative child care providers are not reimbursed for days on
36 which the child is absent. The Commission retains this provision based on the contention that
37 unregulated relative providers do not have the same fixed costs as regulated providers do in order
38 to meet regulatory standards.

39
40 **§809.94. Providers Placed on Corrective or Adverse Action by the Texas Department of**
41 **Family and Protective Services**

42 Section 809.94(c) is amended to remove language stating that a parent receiving notification of a
43 provider's corrective action may choose to continue care with the provider if the parent signs the
44 notification acknowledging that the parent is aware of the provider status. The effect of this
45 language is to end the child's care unless the parent signs the notification and acknowledges that
46 the parent chooses to continue care at the facility. Under the CCDBG Act, care cannot end
47 during the 12-month period for a parent's failure to return the acknowledgement to continue care
48 at the facility.

1
2 Therefore, §809.94(c) is amended to state that the parent may transfer the child to another
3 provider without being subject to the Board's transfer policies if the parent requests the transfer
4 within 14 business days of receiving the notification.
5

6 **§809.95. Provider Automated Attendance Agreement**

7 Section 809.95 is amended to clarify that provider misuse of attendance reporting and violation
8 of the requirements in this section are grounds for fraud determination pursuant to Subchapter F
9 of this chapter.
10

11 **SUBCHAPTER F. FRAUD FACT-FINDING AND IMPROPER PAYMENTS**

12 **The Commission proposes the following amendments to Subchapter F:**
13

14 **§809.111. General Fraud Fact-Finding Procedures**

15 Under *Program Integrity* on page 80488, the NPRM preamble provided the following
16 clarification regarding the Administration for Children and Families' (ACF) intent regarding
17 fraud and recoupments:
18

19 ACF would like to clarify that there is no Federal requirement for Lead Agencies to
20 recoup CCDF overpayments, except in instances of fraud. We also strongly
21 discourage such policies as they may impose a financial burden on low-income
22 families that is counter to CCDF's long-term goal of promoting family economic
23 stability. The Act affirmatively states an eligible child "will be considered to meet all
24 eligibility requirements" for a minimum of 12 months regardless of increases in
25 income (as long as income remains at or below 85 percent of SMI) or temporary
26 changes in parental employment or participation in education and training. Therefore,
27 there are very limited circumstances in which a child would not be considered eligible
28 after an initial eligibility determination.
29

30 When implementing their CCDF programs, Lead Agencies must balance ensuring
31 compliance with eligibility requirements with other considerations, including
32 administrative feasibility, program integrity, promoting continuity of care for
33 children, and aligning child care with Head Start, Early Head Start, and other early
34 childhood programs. These proposed changes are intended to remove any uncertainty
35 regarding applicability of Federal eligibility requirements for CCDF and the threat of
36 potential penalties or disallowances that otherwise may inhibit Lead Agencies ability
37 to balance these priorities in a way that best meets the needs of children.
38

39 Existing regulations at §98.60 indicate that Lead Agencies shall recover child care
40 payments that are the result of fraud from the responsible party. While ACF does not
41 define the term fraud and leaves flexibility to Lead Agencies, fraud in this context
42 typically involves knowing and willful misrepresentation of information to receive a
43 benefit. We urge Lead Agencies to carefully consider what constitutes fraud,
44 particularly in the case of individual families.
45

1 In accordance with this guidance, §809.111 is amended to provide a definition of fraud in
2 relation to child care services. The amended rule states that a person commits fraud if, to obtain
3 or increase a benefit or other payment, either for the person or another person, the person:
4 --makes a false statement or representation, knowing it to be false; or
5 --knowingly fails to disclose a material fact.

6
7 This definition is consistent with the definition of fraudulently obtaining benefits under Texas
8 Labor Code §214.001.

9
10 **§809.112. Suspected Fraud**

11 Section 809.112 is amended to clarify specific parental actions that may be grounds for
12 suspected fraud and cause the Board to conduct fact-finding or the Commission to initiate a fraud
13 investigation. These actions include:

- 14 --not reporting or falsely reporting at initial eligibility or at eligibility redetermination:
15 --household composition, or income sources or amounts that would have resulted in
16 ineligibility or a higher parent share of cost; or
17 --work, training, or education hours that would have resulted in ineligibility; or
18 --not reporting during the 12-month eligibility period:
19 --changes in income or household composition that would cause the family income to
20 exceed 85 percent SMI (taking into consideration fluctuations of income); or
21 --a permanent loss of job or cessation of training or education that exceeds 90 days; and
22 --improper or inaccurate reporting of attendance.

23
24 **§809.113. Action to Prevent or Correct Suspected Fraud**

25 Section 809.113 is amended to remove the provision that a child care contractor may take certain
26 actions if a provider or parent has committed fraud. Although a Board's child care contractor is
27 expected to take these actions, the language implied that the contractor determines which action
28 to take without the involvement of the Board or the Commission.

29
30 Amended language in §809.113 clarifies that actions taken against a provider or parent shall be
31 consistent with and pursuant to Commission policy.

32
33 Further, §809.113 is amended to include the following options:

- 34 --A provider may be prohibited from future eligibility to provide Commission-funded child care
35 services; and
36 --A parent's eligibility may be terminated during the 12-month eligibility period if eligibility was
37 determined using fraudulent information provided by the parent.

38
39 **§809.115. Corrective Adverse Actions**

40 Section 809.115 is amended to remove §809.115(b)(4) to remove termination of child care
41 services as a possible corrective action for parents' noncompliance with this chapter.

42
43 **§809.116. Recovery of Improper Payments**

44 Section 809.116 is repealed and combined with §809.117.

45
46 **§809.117. Recovery of Improper Payments to a Provider or Parent**

1 Section 809.117 is amended to clarify the circumstances in which parents are required to repay
2 improper payments. The language clarifies that a parent shall repay improper payments only in
3 the following circumstances:

4 --Instances involving fraud;

5 --Instances in which the parent has received child care services awaiting an appeal and the
6 determination is affirmed by the hearing officer; or

7 --Instances in which the parent fails to pay the parent share of cost and the Board's policy is to
8 pay the provider for the parent's failure to pay the parent share of cost.

9
10 Section 809.117 is amended to prohibit a parent subject to the repayment provisions above from future
11 child care eligibility until the repayment amount is recovered, provided that the prohibition does not result
12 in a Choices or SNAP E&T participant becoming ineligible for child care.

13 14 **PART III. IMPACT STATEMENTS**

15 Randy Townsend, Chief Financial Officer, has determined that for each year of the first five
16 years the rules will be in effect, the following statements will apply:

17
18 There are no additional estimated costs to the state and to local governments expected as a result
19 of enforcing or administering the rules.

20
21 There are no estimated cost reductions to the state and to local governments as a result of
22 enforcing or administering the rules.

23
24 There are no estimated losses or increases in revenue to the state or to local governments as a
25 result of enforcing or administering the rules.

26
27 There are no foreseeable implications relating to costs or revenue of the state or local
28 governments as a result of enforcing or administering the rules.

29
30 There are no anticipated economic costs to persons required to comply with the rules.

31
32 There is no anticipated adverse economic impact on small or microbusinesses as a result of
33 enforcing or administering the rules.

34
35 While we are not concluding any net increase or decrease to the cost of the child care program
36 administered by TWC and Boards as a result of these proposed rules, it is pertinent to take note
37 that there will likely be an impact to the child care program, possibly to somewhat reduce child
38 care operational and administrative costs, somewhat increase the cost of some individual units of
39 child care, and possibly to increase waiting lists for subsidized child care. While these individual
40 impacts cannot easily be quantified at this time, we note that they are necessary due to the
41 enactment of federal statutory revisions and the impending effective date of federal regulations,
42 and not created by these proposed rules.

43 44 Economic Impact Statement and Regulatory Flexibility Analysis

45 The Agency has determined that the proposed rules will not have an adverse economic impact on
46 small businesses as these proposed rules place no requirements on small businesses, including
47 child care providers.

1 Doyle Fuchs, Director of Labor Market and Career Information, has determined that there is no
2 significant negative impact upon employment conditions in the state as a result of the rules.

3
4 Reagan Miller, Director, Workforce Development Division, has determined that for each year of
5 the first five years the rules are in effect, the public benefit anticipated as a result of enforcing the
6 proposed rules will be to ensure compliance with the CCDBG Act, and to provide efficient and
7 effective subsidized child care services that promote both child development and parent
8 workforce participation.

9
10 The Agency hereby certifies that the proposal has been reviewed by legal counsel and found to
11 be within the Agency's legal authority to adopt.

12
13 **PART IV. COORDINATION ACTIVITIES**

14 In the development of these rules for publication and public comment, the Commission sought
15 the involvement of Texas' 28 Boards. Agency executive management discussed the policy
16 concept with the Board executive directors during the March 29, 2016, Executive Director
17 Council meeting and Agency staff presented the policy concept to Board staff during the March
18 29, 2016, workforce forum. During the rulemaking process, the Commission considered all
19 information gathered in order to develop rules that provide clear and concise direction to all
20 parties involved.

10 prevention of fraud by a parent, provider, or any other person in a position to commit
11 fraud consistent with fraud prevention provisions in the Agency-Board Agreement.

13 (b) In this subchapter, a person commits fraud if, to obtain or increase a benefit or other
14 payment, either for the person or another person, the person:

16 (1) makes a false statement or representation, knowing it to be false; or

18 (2) knowingly fails to disclose a material fact.

20 (c)(b) A Board shall ensure that procedures for researching and fact-finding for possible
21 fraud are developed and implemented to deter and detect suspected fraud for child
22 care services in the workforce area.

23
24 (d)(e) These procedures shall include provisions that suspected fraud is reported to the
25 Commission in accordance with Commission policies and procedures.

26
27 (e)(d) Upon review of suspected fraud reports, the Commission may either accept the
28 case for investigation and action at the state level, or return the case to the Board or
29 its child care contractor for action including, but not limited to, the following:

30
31 (1) further fact-finding; or

32
33 (2) other corrective action as provided in this chapter or as may be appropriate.

34
35 (f)(e) The Board shall ensure that a final fact-finding report is submitted to the
36 Commission after a case is returned to the Board or its child care contractor and all
37 feasible avenues of fact-finding and corrective actions have been exhausted.

41 (a) A parent, provider, or any other person in a position to commit fraud may be
42 suspected of fraud if the person presents or causes to be presented to the Board or its

(c) When a provider violates a provision of Subchapter E of this chapter, a written Service Improvement Agreement may be negotiated between the provider and the Board or the Board's child care contractor. At the least, the Service Improvement Agreement shall include the following:

- (1) The basis for the Service Improvement Agreement;
- (2) The steps required to reach compliance including, if applicable, technical assistance;
- (3) The time limits for implementing the improvements; and
- (4) The consequences of noncompliance with the Service Improvement Agreement.

(d) The Board shall develop policies and procedures to ensure that the Board or the Board's child care contractor take corrective action consistent with subsections (a) - (c) of this section against a provider when a provider:

- (1) possesses, or has on the premises, attendance cards without the parent being present at the provider site;
- (2) accepts or uses an attendance card or PIN of a parent or secondary cardholder;
or
- (3) performs the attendance reporting function on behalf of a parent.

(e) The Board shall develop policies and procedures to require the Board's child care contractor to take corrective action consistent with subsections (a) - (c) of this section against a parent when a parent or parent's secondary cardholder gives his or her:

- (1) card to a provider; or
