Subchapter A. Vocational Rehabilitation General Rules, §850.11

20 PART I. PURPOSE, BACKGROUND, AND AUTHORITY

- 21 The purpose of the proposed Chapter 850 rule change is to clarify TWC's Vocational
- 22 Rehabilitation Division's (VRD) Comprehensive System of Personnel Development (CSPD)
- 23 standards for Qualified Vocational Rehabilitation Counselors (QVRCs) in accordance with 34
- 24 Code of Federal Regulations (CFR) §361.18, relating to vocational rehabilitation personnel
- 25 development.26

27 PART II. EXPLANATION OF INDIVIDUAL PROVISIONS

- 28 (Note: Minor editorial changes are made that do not change the meaning of the rules and,
- 29 therefore, are not discussed in the Explanation of Individual Provisions.)

31 SUBCHAPTER A. VOCATIONAL REHABILITATION GENERAL RULES

32 TWC proposes the following amendments to Subchapter A:

33 <u>§850.11. Qualified Vocational Rehabilitation Counselor</u>

- 35 Section 850.11 is repealed and added as new to clarify requirements for QVRCs.
- 36
- 37 The current rule language in §850.11(a) (f) is repealed and proposed as new in new §850.11
- 38 with the updated QVRC requirements. The current rule language is added throughout new
- 39 §850.11(e) (j), except for current §850.11(d) because the rule language is no longer applicable.
- 40
- The repealed rule language in §850.11(e) is added into two subsections in new §850.11 asfollows:
- 43 -- The rule language regarding the time period for completing the graduate education
- 44 requirements is added into new §850.11(e).
- 45 -- The rule language regarding transcript reviews and confirming certifications is moved from
- 46 repealed §850.11(e) to new §850.11(f).

1 2 3 4 5 6	Additionally, the repealed rule language in current §850.11(a) and (f) is moved, with modifications, to new §850.11(g) and (j), respectively, to align with and clarify the updated QVRC requirements. New §850.11(a) clarifies that VRD develops and maintains the CSPD standards.
7 8	New §850.11(b) specifies what is needed for staff to be classified as a QVRC.
9 10	New §850.11(c) specifies what staff must do to be qualified to perform non-delegable duties.
11 12 13	New §850.11(d) specifies the minimum education and experience standards required to be hired as a VR counselor.
14 15 16	New §850.11(e) specifies the graduate education requirements that must be completed within seven years from completion of the initial training year.
17 18 19	New §850.11(f) specifies that VRD must conduct transcript reviews and/or confirm certifications to determine compliance with standards, coursework, and graduate education requirements.
20 21 22	New §850.11(g) is the rule language that was repealed from current §850.11(a), with modifications, to align with and clarify the updated QVRC requirements.
23 24 25	New §850.11(h) relating to QVRC financial assistance is the rule language that was repealed from current §850.11(b).
26 27 28	New §850.11(i) relating to the requirements for applying for QVRC program assistance is the rule language that was repealed from current §850.11(c).
29 30 31	New §850.11(j) is the rule language that was repealed from current §850.11(f), with modifications, to align with and clarify the updated QVRC requirements.
32 33 34 35	PART III. IMPACT STATEMENTS Chris Nelson, Chief Financial Officer, has determined that for each year of the first five years the rules will be in effect, the following statements will apply:
36 37 38	There are no additional estimated costs to the state and to local governments expected as a result of enforcing or administering the rules.

- 7 Based on the analyses required by Texas Government Code §2001.024, TWC has determined
- 8 that the requirement to repeal or amend a rule, as required by Texas Government Code
- 9 §2001.0045, does not apply to this rulemaking.

- 11 Takings Impact Assessment
- 12 Under Texas Government Code, §2007.002(5), "taking" means a governmental action that
- 13 affects private real property, in whole or in part or temporarily or permanently, in a manner that
- 14 requires the governmental entity to compensate the private real property owner as provided by
- 15 the Fifth and Fourteenth Amendments to the US Constitution or the Texas Constitution, §17 or
- 16 §19, Article I, or restricts or limits the owner's right to the property that would otherwise exist in
- 17 the absence of the governmental action, and is the producing cause of a reduction of at least 25
- 18 percent in the market value of the affected private real property, determined by comparing the
- 19 market value of the property as if the governmental action is not in effect and the market value of
- 20 the property determined as if the governmental action is in effect. TWC completed a Takings
- 21 Impact Assessment for the proposed rulemaking action under Texas Government Code,
- 22 §2007.043. The primary purpose of this proposed rulemaking action, as discussed elsewhere in
- 23 this preamble, is to clarify requirements for QVRCs.
- 24
- 25 The proposed rulemaking action will not create any additional burden on private real property or
- affect private real property in a manner that would require compensation to private real property
- owners under the US Constitution or the Texas Constitution. The proposal also will not affect
- 28 private real property in a manner that restricts or limits an owner's right to the property that
- would otherwise exist in the absence of the governmental action. Therefore, the proposed
- 30 rulemaking will not cause a taking under Texas Government Code, Chapter 2007.
- 31
- 32 Government Growth Impact Statement
- 33 TWC has determined that during the first five years the rules will be in effect, they:
- 34 --will not create or eliminate a government program;
- 35 --will not require the creation or elimination of employee positions;
- 36 --will not require an increase or decrease in future legislative appropriations to TWC;

- 27 amend, or repeal such rules as it deems necessary for the effective administration of TWC
- 28 services and activities.

CHAPTER 850. VOCATIONAL REHABILITATION SERVICES ADMINISTRATIVE RULES AND PROCEDURES SUBCHAPTER A. VOCATIONAL REHABILITATION GENERAL RULES **§850.11. Qualified Vocational Rehabilitation Counselor.** (a) The Vocational Rehabilitation Division (VRD) helps vocational rehabilitation (VR) counselors to meet the Comprehensive System of Personnel Development (CSPD) standard, as set forth in 34 Code of Federal Regulations §361.18, by making funds available through the Qualified Vocational Rehabilitation Counselor (QVRC) program for the required graduate education except when: (1) unforeseen circumstances occur that may restrict or prohibit the funding; or (2) VRD management discontinues a VR counselor's participation in the program in the best interests of VRD. (b) The VRD director or designee must approve QVRC financial assistance. This financial assistance is contingent on: (1) funding; (2) VRD management approval; and (3) compliance with qualifications for participation. (c) Qualifications for participation in the QVRC program require that VR counselors and transition VR counselors applying for assistance must: (1) have completed the initial training year; (2) be meeting or exceeding job performance expectations; (3) obtain the appropriate approvals to pursue a graduate degree or prescribed coursework; (4) apply for Rehabilitation Services Administration scholarship and university stipend funding, if applicable; and (5) be accepted by the appropriate institution of higher education. (d) A VR counselor who meets the CSPD standard is considered a QVRC. (e) A VR counselor is expected to meet the CSPD standard within seven years from completion of the initial training year. VRD must conduct transcript reviews and/or confirm certifications to determine compliance with standards or to outline

3 4	(f) A VR counselor is expected to pay all costs or expenses:
5	(1) associated with the college application, admission, and GRE exam
6	(reimbursement of one GRE exam is allowed);

11	(3) related to completing work necessary to remove any grade of "I" (Incomplete)
12	within three months, unless there are valid reasons (for example, serious

15	<u>8850.11. Quantieu vocational Kenabintation Counselor.</u>
10	(a) The Vocational Rehabilitation Division (VRD) develops and maintains a
18	<u>Comprehensive System of Personnel Development (CSPD). This system includes</u>
19	procedures to ensure VRD maintains an adequate supply of qualified personnel,
20	referred to as Qualified Vocational Rehabilitation Counselors (QVRCs).
21	
22	(b) To classify as a QVRC, staff must meet specific state requirements related to
23	education and experience. Standards for QVRCs serve as an internal control to
24	ensure staff are sufficiently trained and prepared to effectively serve Texans with
25	disabilities.
26	
27	(c) VR counselors are considered qualified to perform non-delegable duties upon
28	meeting the minimum initial standards for hire, successful completion of required
29 30	training, and an initial probationary period that allows demonstration of performance. The minimum initial standards for hire are aligned with 34 CFR
30	§361.18(c)(1)(ii)(A) and the State of Texas VR Counselor Classification Schedule.
32	<u>§ 501.16(c)(1)(I)(A) and the State of Texas VK Counselor Classification Schedule.</u>
33	(d) Minimum initial standards for hire as a VR counselor include the following
34	education and experience requirements:
35	<u>.</u>
36	(1) <u>A bachelor's degree in a field of study reasonably related to vocational</u>
37	rehabilitation, to indicate a level of competency and skill demonstrating basic
38	preparation in a field of study such as vocational rehabilitation counseling,
39	social work, psychology, disability studies, business administration, human
40	resources, special education, supported employment, customized employment,
41	economics, or another field that reasonably prepares individuals to work with
42	customers and employers; and
43	(2) Demonstrated noid or unnoid experience for not less then one year experience
44 45	(2) Demonstrated paid or unpaid experience, for not less than one year, consisting of:

1 2	(A) Direct work with individuals with disabilities in a setting such as an independent living center;
3 4	(B) Direct service or advocacy activities that provide such individual with
5 6	experience and skills in working with individuals with disabilities; or

20 21 22	(3) A master's, specialist, or doctoral degree in specific majors with required specified coursework identified by the Agency's VR division;
23 24 25	(4) A current certified rehabilitation counselor (CRC) certificate from the Commission on Rehabilitation Counselor Certification (CRCC); or
26 27 28	(5) Current licensure for a licensed professional counselor (LPC).
29 30 31	(f) VRD must conduct transcript reviews and/or confirm certifications to determine compliance with standards or to outline coursework to be completed by the VR counselor to meet graduate education requirements.
32 33 34 35	(g) VRD helps VR counselors to advance as QVRCs by making funds available through the Qualified Vocational Rehabilitation Counselor (QVRC) program for the required graduate education except when:
36 37 38	(1) unforeseen circumstances occur that may restrict or prohibit the funding; or
39 40	(2) VRD management discontinues a VR counselor's participation in the program in the best interests of VRD.
41 42 43	(h) The VRD director or designee must approve QVRC financial assistance. This financial assistance is contingent on:
44 45 46	(1) funding;
