# AMENDMENT TWO CONTRACT NUMBER 3123ITC018 BY AND BETWEEN TEXAS WORKFORCE COMMISSION AND INTERNATIONAL BUSINESS MACHINES CORPORATION

This Amendment Two (the "Amendment") to Contract Number 3123ITC018 (the "Contract"), is entered into by and between International Business Machines Corporation and the Texas Workforce Commission (TWC), also hereinafter referred to collectively as "the Parties," or individually as a "Party."

**WHEREAS**, the Parties entered into the Contract, effective October 6, 2022, for the purposes of assessing the TWC Cloud Migration; and

- 2.1 This Amendment Two together with Amendment One and the Contract represents the entire agreement between the Parties concerning the subject matter of this Contract and supersede any and all prior or contemporaneous oral or written statements, agreements or negotiations.
- 2.2 Except as expressly amended herein, all other terms of the Contract remain unchanged, are in full force and effect, and are ratified and affirmed by the Parties.
- 2.3 In the event of conflicting language between the Contract and the language in this Amendment, the language in this Amendment shall control.

#### **SECTION 3 – SIGNATURES**

The Parties agree that signatures on this Contract are valid if signed by an individual authorized to obligate that Party whether that individual's signature is hand-made or represented electronically or digitally as those terms are defined by 34 Texas Administrative Code § 20.3.
