23	amended Texas Education Code, Title 3, Subtitle G, by adding Chapter 134A relating to
24	the creation of the Lone Star Workforce of the Future Fund. HB 1755 tasks TWC with
25	the establishment and administration of the Lone Star Workforce of the Future Fund as a
26	dedicated account in the general revenue fund. Furthermore, HB 1755 requires TWC to
27 28	adopt rules as necessary to administer this chapter.

The proposed rulemaking action will not create any additional burden on private real property or affect private real property in a manner that would require compensation to private real property owners under the US Constitution or the Texas Constitution. The proposal also will not affect private real property in a manner that restricts or limits an owner's right to the property that would otherwise exist in the absence of the
