Middle Skills Employment Supplies Pilot Project Discussion Paper

4 Background

The Workforce Solutions system offers a variety of supportive services to Texans enrolled in 5 WIOA services who are currently in training or seeking new employment. In communication 6 with a variety of partners, Texas Workforce Commission staff have identified an opportunity to 7 pilot an initiative to support Texans preparing to join the workforce but who are taking training 8 outside of current WIOA programs. Workforce Development Boards (Boards) will partner with 9 other non-profit and community programs and other state agencies that provide training and 10 11 certifications for middle skills occupations (requiring some education beyond high school but less than a four-year degree), but that have limited or no funds to purchase tools or supplies that are 12 required by these occupations. Many employers, particularly in middle-skills industries, require 13 specific tools or supplies. Additionally, workers often need support services such as clothing, 14 transportation and childcare to accept an offer of employment. This program will provide funds 15 to Boards to assist these individuals by allowing the purchase of the specific items required by 16

17 the employer and support services needed.

- 19 Issue20 Funds would be distributed to the Boards to partner with non-profit and community providers
- 21 and other state agencies that support training and certifications in middle-skills jobs. A Board's
- current WIOA customers are also eligible for these funds, when a Board had obligated all
- available client service funding and the customer has a letter of intent to hire. TWC places
- 24 emphasis on priority populations defined in the WIOA Guide and also individuals who are
- incarcerated at local correctional facilities who are scheduled for release within 60 days to
- support Texans that are re-entering the workforce post training.

28 **Recommendations**

- 29 Staff recommends the commission approve the distribution of up to \$2 million dollars in WIOA
- 30 Statewide Funds, with a \$30,000 base amounts, to the boards to fund this Middle Skills
- Employment Support Pilot Project. Boards will develop a form which collects all required
- information to determine WIOA eligibility and will ensure that eligibility is documented within 2
- business days of identified need. Eligibility for WIOA Statewide Funding includes:
- at least 18 years of age
 - authorized to work in the U.S., and
 - meets Selective Service requirements
