

## MEETING OF THE TEXAS WORKFORCE COMMISSION

JULY 11, 2023

1	Tuesday, July 11, 2023
2	CHAIRMAN DANIEL: Good morning, everyone.
3	This meeting is called to order. Mr. Trobman, has anyone signed
4	up for public comment?
5	MR. TROBMAN: No, sir.
6	CHAIRMAN DANIEL: Thank you, Mr. Trobman.
7	Good morning, Ms. Gonzales.
8	MS. GONZALES: Good morning.
9	CHAIRMAN DANIEL: All right, this brings us
10	to the end of Agenda Items 3 through 7. We'll take a short
11	recess.
12	CHAIRMAN DANIEL: All right, we're back.
13	We're going to start actually with Agenda Item 13. The time is
14	now 10:38. The Texas Workforce Commission is now going into
15	executive session to discuss the appointment, employment,
16	evaluation, reassignment, duties, discipline, or dismissal of
17	the executive director, internal auditor, executive staff, and
18	other personnel pursuant to Texas Government Code 551.074(a)(1).
19	CHAIRMAN DANIEL: All right, the executive
20	session is now completed. The time is 10:54. Let's move back and
21	take up Agenda Item 8, Board Contract Year 2024 Texas Rising
22	Star Mentor Distribution.
23	REAGAN MILLER: Good morning, chairman,
24	commissioners. For the record, Reagan Miller with the Child Care
25	& Early Learning Division. Today we're bringing forward

1	recommendations on how to distribute the \$25,000,000-excuse me,
2	the \$27,000,000 that you previously approved within the
3	Statewide Initiatives budget to support Texas Rising Star
4	mentors in Board Contract Year 2024. As we outline in the paper
5	with the implementation of the legislative change to mandate
6	that all CCS providers participate in the Texas Rising Star
7	program, there will be many more child care programs in need of
8	mentoring and coaching assistance. The increase in funding will
9	allow boards to hire additional Texas Rising Star mentors to
10	provide this support. The funding distribution methodology is
11	the same as last year and is described in detail in the
12	discussion paper, and on page three you'll see the amounts that
13	each board will receive based on this recommended distribution.
14	That concludes my overview and I'm happy to answer any questions
15	that you have.
16	CHAIRMAN DANIEL: Any comments or questions?
17	COMMISSIONER DEMERSON: This is kind of an
18	aside, Reagan. Congratulations to you and your team on an
19	amazing child care conference that was recently held. This
20	particular item, mentoring, coaching, all those things, I had an
21	opportunity to visit with the various vendors and got kind of
22	churched up on all these areas, and so that additional funding
23	that this commission is allocated and appropriated, your teams
24	put it to good use and those vendors are the ones that are
25	performing that work were engaged. I enjoyed the conversations

1	but congratulations on that conference. No other comments, Mr.
2	Chairman.
3	COMMISSIONER TREVIÑO: I just wanted also to
4	concur with Commissioner Demerson on a wonderful conference. It
5	seemed like everything ran so smoothly and everybody was excited
6	to be there so congratulations.
7	CHAIRMAN DANIEL: Is there a motion?
8	COMMISSIONER DEMERSON: I move that we
9	approve the Board Contract Year 2024 Texas Rising Star mentor
10	distribution as described in the discussion paper and
11	recommended today by staff.
12	COMMISSIONER TREVIÑO: I second the motion.
13	CHAIRMAN DANIEL: It's been moved and
14	seconded and we're unanimous.
15	REAGAN MILLER: Thank you.
16	CHAIRMAN DANIEL: This is Agenda Item 9,
17	Board Nominations.
18	CHERIE DUDLEY: Good morning, chairman,
19	commissioners, and Mr. Serna. For the record, Cherie Dudley with
20	Workforce Development. Today for your consideration we have
21	Workforce nominations for Brazos Valley, Capital Area, Golden
22	Crescent, Coastal Bend, Panhandle, Permian Basin, and Texoma.
23	Staff recommends approval on the presented nominees and I'm here
24	to answer questions you may have.
25	CHAIRMAN DANIEL: Any questions?

1	COMMISSIONER DEMERSON: No questions.
2	COMMISSIONER TREVIÑO: No questions.
3	CHAIRMAN DANIEL: No questions. Is there a
4	motion?
5	COMMISSIONER DEMERSON: I move that we
6	approve the local Workforce Development Board member nominees
7	presented today for the following Workforce Solutions offices:
8	Workforce Solutions Brazos Valley, Capital Area, Golden
9	Crescent, Coastal Bend, Panhandle, Permian Basin, and Texoma.
10	COMMISSIONER TREVIÑO: I second the motion.
11	CHAIRMAN DANIEL: It's been moved and
12	seconded and we're unanimous. Thank you.
13	CHERIE DUDLEY: Thank you.
14	CHAIRMAN DANIEL: I do not see a legislative
15	report today. Is there an executive director's report today?
16	MR. SERNA: Yes, sir, there is. Two things
17	actually. The first is a matter of personal privilege to just
18	let everybody know that today is Commissioner Demerson's
19	birthday and wish the commissioner a happy birthday.
20	COMMISSIONER DEMERSON: Thank you, Ed.
21	MR. SERNA: The second is-
22	CHAIRMAN DANIEL: He didn't give you any
23	time for rebuttal. Did you notice that? He's like, happy
24	birthday, and OK, and the next thing on my list is-
25	COMMISSIONER DEMERSON: Because Ed knows.

1	MR. SERNA: He said thank you and I heard
2	that and I was [inaudible].
3	COMMISSIONER DEMERSON: And then you were
4	done.
5	MR. SERNA: Well, I was afraid that there
6	would be a request for singing or something like that. The
7	second item is recognizing staff. Our Fraud Detection and
8	Compliance Monitoring Division nominated one of the teams, the
9	AD&M team in IT for outstanding work, and we're going to
10	recognize those employees with a Star Award and Chuck can
11	describe that.
12	CHUCK ROSS: Good morning, Mr. Chairman,
13	commissioners, Mr. Serna. For the record, my name is Chuck Ross.
14	I'm the director of TWC's Division of Fraud Deterrence and
15	Compliance Monitoring. I'll start out by saying it's probably
16	never a good thing when the fraud guy shows up but I'm here for
17	actually a very pleasant reason, and I'm not wearing my
18	traditional undertaker garb to kind of put that-kind of forward
19	that vibe. I'm here to speak to you all about a group award,
20	Star Award, for the IT department's Application, Development,
21	and Maintenance Division. It's no surprise to anybody in the
22	agency or to anybody in Texas that during the pandemic the
23	unemployment insurance program became a huge target for ID
24	theft. All told we had close to 900,000 potential ID theft
25	claims that really were filed by criminal enterprises. Integrity

1 and fraud protection is really a team sport at the agency, and 2 while my division and the UI division and other divisions work 3 diligently to investigate these ID theft claims, the IT division 4 in particular, AD&M, really showed up and helped out with 5 victims of ID theft primarily in the area of those individuals 6 whose identifications were stolen but then they subsequently 7 needed to file a claim for unemployment benefits. That process 8 involves kind of unwinding the Social Security number of the 9 victim, moving the fraud ID information to a pseudo-claim, and 10 then allowing the victim of the ID theft to claim-file a 11 legitimate claim for benefits because they were unemployed and 12 needed the money. So prior to November of 2020, that process 13 involved looking at dozens and dozens of tables in the benefits 14 system and just sort of untangling the fraud claim. It took IT 15 staff four to six hours per individual claim to do that work. I 16 really want to recommend Sharla Roberts because she took the 17 current process and on her own initiative and her extremely 18 intelligent approach, she automated that system so that the four 19 to six hours it was taking took 15 minutes for us to unwind and 20 attach ID theft claims to pseudo-SSNs so after that process we 21 were able to help over 3,400 victims of ID theft be able to file 22 legitimate claims for unemployment insurance. That's really kind 23 of the vanguard of the work that the AD&M shop did but they were 24 instrumental to our efforts, and I'd like to-and it's my 25 privilege and my honor because I work with them on a regular

1 basis to commend them to you as award winners of the Star Award. 2 First, Sharla Roberts. She coded the ID theft Moves [SP] 3 application for complicated pseudo-moves for the CARES and the 4 ARPA payments. I'm tearing up a little bit about Sharla's 5 nomination because unfortunately she is no longer with TWC, and 6 that makes me very sad, and a lot of people are very sad about 7 that. Next, I'd like to recognize Rine Everett. Rine coded an 8 automated script to use the existing screen to perform basic 9 pseudo-moves. Again, it really helped victims of ID theft. 10 Brandi Cordell and Rine Everett documented and tested all the ID 11 theft requirements results. Beatriz Silva trained 15 staff to do 12 the ID moves that were necessary to help these victims. Michael 13 Weaver documented and tested all CARES, ARPA, and related 14 overpayments, and kind of a special shoutout to Michael Weaver. He writes the best technical documents I've ever read. I can 15 16 barely charge my iPhone but I understand exactly what he tells 17 me so kudos to Michael. Rolando Tovar, he coded and is currently coding all [inaudible] overpayments, and finally David Leandro, 18 19 Joseph Henry, Retha Madison, Denise Williams, and Rebecca 20 Roberts completed manual entry of theft moves. That's only-what 21 I've laid out here is only a small amount of the contributions 22 that the AD&M shop has made to fraud, waste, and abuse 23 prevention at TWC, and it was my honor to submit them for 24 awards, and that's what I have for you today. 25 CHAIRMAN DANIEL: Any comments or questions?

1	COMMISSIONER DEMERSON: A couple of comments
2	here. Chuck, thanks for the presentation and the nominating.
3	Chuck, you mentioned the wardrobe. We need to see pics on that
4	wardrobe that you have [inaudible], but in all seriousness, want
5	to congratulate the IT team, and I'm going to mention some folks
6	here, Sharla, Rine, Brandi, Beatriz, Michael, Rolando, David,
7	Joseph, Retha, Denise, and Rebecca, all their hard work. Tommy
8	Simmons on my team kind of pointed out the fact that this is the
9	second time that the AD&M team has been recognized for an
10	outstanding contribution towards detection and prevention of UI
11	claim fraud. Back in 2018 they were recognized as well for the
12	work that they were doing there, and so we have a strong
13	appreciation for the work that's been done and appreciate the
14	relationship that we have with you guys, and so thank you guys
15	for all you do and congratulations to that team for achieving
16	this recognition.
17	COMMISSIONER TREVIÑO: I too just want to
18	say congratulations to the AD&M team for their hard work and
19	exceptional service for the fraud-related issues and identifying
20	the identity theft and overpayments and other hard work and
21	dedication. Truly appreciated. Sorry we're losing or we lost
22	Sharla too.
23	CHAIRMAN DANIEL: I'd say two things. First
24	thing is, you know, people don't really-and sometimes for good
25	reason, don't have a real concept of all the moving parts that

1	go in to protecting the taxpayers' dollars, and all the things
2	that happen at the agency. We probably don't show those for
3	reasons we don't want the bad guys to know what we're doing but
4	I definitely want to know the people that are making it happen.
5	I'm glad you did this. I'm glad you brought this forward today.
6	The second thing that I want to mention is we need to remember
7	that's Chuck's good news shirt so we'll pay attention when he's
8	wearing that shirt in the staff briefings and stuff so we have
9	an idea of what's about to happen. He told us that at the
10	beginning.
11	COMMISSIONER DEMERSON: Picking up
12	[inaudible].
13	CHAIRMAN DANIEL: I was getting some good
14	stuff.
15	MR, SERNA: Very good point.
16	CHAIRMAN DANIEL: Congratulations to all the
17	[inaudible], Chuck. Thanks for bringing this forward.
18	CHUCK ROSS: Thank you.
19	MR. SERNA: That's all that I had to report,
20	commissioner.
21	COMMISSIONER DEMERSON: Before you
22	[inaudible], let's give the a round of applause and ask them all
23	to stand. Thank you. All right.
24	CHAIRMAN DANIEL: All right. Is there any
25	other order of business to come before the commission.

1	COMMISSIONER DEMERSON: I don't think-we
2	have next week so OK.
3	COMMISSIONER TREVIÑO: None here.
4	CHAIRMAN DANIEL: None here either. Award
5	winners, hang around. I want to shake your hand and will
6	entertain a motion to adjourn.
7	COMMISSIONER DEMERSON: So moved.
8	COMMISSIONER TREVIÑO: I second the motion.
9	CHAIRMAN DANIEL: It's been moved and
10	seconded to adjourn, and we're adjourned. Thank you.
