Income Amounts for Determining Eligibility and Parent Share of Cost for

Child Care Services

PURPOSE:

The purpose of this WD Letter is to provide Local Workforce Development Boards (Boards) with the federal poverty guidelines (FPG) and state median income (SMI) amounts used to determine family eligibility and parent share of cost for child care services in Board Contract Year 2024 (BCY'24).

RESCISSIONS:

WD Letter 20-22 (as of October 1, 2023)

BACKGROUND:

Texas Workforce Commission (TWC) Chapter 809 Child Care Services rule <u>\$809.41</u> requires Boards to set family income limits for child care eligibility that do not exceed 85 percent of the SMI. TWC's three-member Commission <u>amended</u> \$809.41 to establish a statewide income eligibility limit of 85 percent of the SMI.

Additionally, §809.19(a)(1)(A)(ii) requires Boards to set a policy that assesses the parent share of cost as "an amount determined by a sliding fee scale based on the family's size and gross monthly income . . ." and that "also may consider the number of children in care."

PROCEDURES:

No Local Flexibility (NLF): This rating indicates that Boards must comply with the federal and state laws, rules, policies, and required procedures set forth in this WD Letter and have no local flexibility in determining whether and/or how to comply. All information with an NLF rating is indicated by "must."

Local Flexibility (LF): This rating indicates that Boards have local flexibility in determining whether and/or how to implement guidance or recommended practices set

forth in this WD Letter. All information with an LF rating is indicated by "may" or "recommend."

NLF: Effective October 1, 2023, Boards must use the:

- BCY'24 income data in Attachment 1, Board Contract Year 2024 Income Limit Eligibility Code Card for Child Care Services, to determine eligibility for child care services; and
- BCY'24 income ranges in Attachment 2, Income Ranges for Parent Share of Cost Assessment, to assess the parent share of cost.
- **NLF:** Boards must use the SMI range to determine income limits for child care eligibility.
- <u>NLF</u>: Boards must ensure that income limits do not exceed 85 percent of SMI statewide, as established in §809.41.

<u>LF</u>: Boards may:

- use the SMI income range to assess the parent share of cost;
- adjust the parent share of cost amount for SMI range¹; and
- continue to use the BCY'23 parent share of cost amount for SMI income range for BCY'23 without Board action in an open meeting.

NLF: Boards must ensure that the appropriate staff member enters the updated BCY'24 parent share of cost amount that becomes effective October 1, 2023 (BCY'24), into The Workforce Information System of Texas (TWIST) by using the WDA Administration's Share of Cost tab and selecting Child Care Administration from the drop-down menu.
